- B. Proposed Bill Amendments
 - 1. Change the implementation date for the certification of law enforcement officers from June 30, 2023 to June 30, 2024.
 - Exempt position for office assistant/clerical position. Proposal to make that position also exempt from civil service, Chapter 76, HRS, like the administrator position. Would facilitate the management by the Board.

<u>SB 1046, SD1</u>:

On page 13, line 6, and page 17, lines 15-16: administrator position excepted from civil service, section 76-16, HRS.

On page 21, lines 16-20: 1 FTE Administrator, exempt from ch 76, and 1 FTE clerical, subject to ch 76.
