### **Deputy to the Commanding General**

Mr. Dan Gallagher is the Deputy to the Commanding General U.S. Army Contracting Command (ACC) Redstone Arsenal, Alabama. He is the Commanding General's principal civilian authority and proponent on mission management functions, operations and activities. He assumed the position on February 25, 2024.

ACC, a subordinate command to the Army Materiel Command, is comprised of a subordinate one-star command, six major contracting centers and eight contracting support brigades. ACC enables Army readiness through global, expeditionary contracting support to warfighters engaged in military operations, weapon systems acquisition, life cycle management, sustainment and acquisition of goods and services vital to the Soldier's mission and well-being. Its workforce includes more than 6,000 military and civilian personnel at more than 100 locations worldwide. Annually ACC awards more than 140,000 contract actions valued at approximately \$70 billion.



Prior to becoming the ACC-Deputy to the Commander Mr. Gallagher served as the Executive Director and Senior Contracting Official for ACC Detroit Arsenal, Michigan.

Mr. Gallagher is a retired Army colonel who began his military career when he was commissioned following graduation from California University of Pennsylvania as an ROTC Distinguished Military Graduate. His military education includes the Ordnance Officer Basic and Advanced Courses, Combined Arms Service Staff School, Training with Industry at General Dynamics in Pomona, California, the U.S. Army Command and General Staff College and the U.S. Army War College.

Mr. Gallagher has served in numerous Army command and staff positions. His key assignments include Deputy Director, Contracting Operations, Army Contracting Command Redstone Arsenal, Alabama, Deputy to the Commanding General, Expeditionary Contracting Command (ECC), the Contracting Operations Director for the ECC Redstone Arsenal, Alabama, the ECC Chief of Staff at Fort Belvoir, Virginia., the Commander of Defense Contract Management Agency Huntsville, Alabama, working in the Pentagon as the DCMA Liaison Officer to the Joint Staff and Executive Officer for the Deputy Assistant Secretary of the Army for Systems Management Office Pentagon Washington, DC, Commander of DCMA Central Pennsylvania, Executive Officer for the Deputy Assistant Secretary of the Army (Procurement) Pentagon Washington, DC, Warranted Contracting Officer and Centralized Contracting Division Chief for the U.S. Army Contracting Command Europe, Wiesbaden, Germany, the Joint Contracting Center Chief for Croatia during Operation Joint Endeavor, New Equipment Fielding Officer for Program Manager Heavy Combat Wheeled Vehicles at the Tank Automotive Command, Warren, Michigan, and deployments to Iraq for Operation Iraqi Freedom, Somalia for Operation Restore Hope and to Southwest Asia for Operation Desert Storm. Served in a wide variety of operational command, leadership and staff assignments in the 82nd Airborne Division Fort Bragg, North Carolina and 1st Armored Division, Germany.

His awards and honors include the Presidential Rank Award, Superior Civilian Service Award and Commanders Award for Civilian Service. His military decorations include the Defense Superior Service Medal, Legion of Merit, Bronze Star, Defense Meritorious Service Medal, Meritorious Service Medal, Army Commendation Medal, Army Achievement Medal, Parachutist Badge, Air Assault Badge and the Department of Army Staff Badge.
