- **Access, edit and update** your current policies and add new policies in real time, right as your school board is amending and adopting.

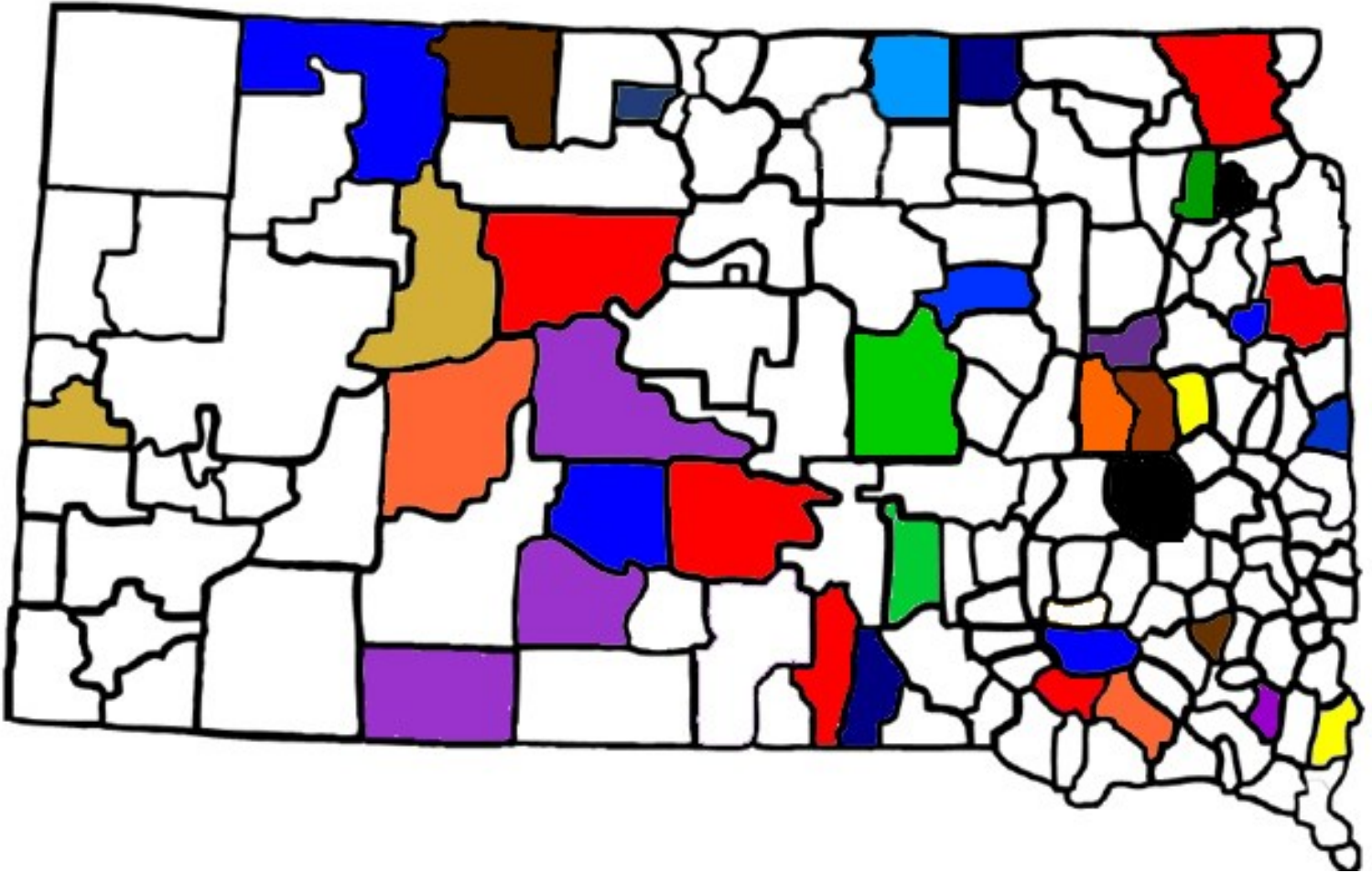
