
The Benefits Bundle pilot assists grantees of the Health Resources and Services Administration's (HRSA) Healthy Start program, a longstanding Federal program to reduce infant mortality rates and address social determinants of health. The Benefits Bundle team developed a new peer-based model to help Healthy Start families navigate the transition to parenthood. For this peer-based model, the team created the role of "Alumni Navigator," a mother who recently completed the Healthy Start program at the pilot location, and has experience navigating benefits enrollment (e.g., Medicaid and WIC) and accessing key community resources and supports. Alumni Navigators are therefore uniquely qualified to provide new families with social, informational, and emotional support and deliver a "bundled" set of critical resources. The six pilot partner grantees have collectively hired 16 Alumni Navigators who have served more than 170 families across grantee sites (Atlanta, Baton Rouge, New York City, Los Angeles, the PeeDee Region, and Turtle Mountain Reservation). The interagency Benefits Bundle team included perspectives from HHS (both ACF and CMS), DOL, HUD, and USDA in developing the "Benefits Bundle" set of resources for Healthy Start families. Among the set of Federal benefits, the Alumni Navigators are focusing on WIC and Medicaid.

The team expects to summarize insights from the six pilots in a *Benefits Bundle Playbook* to inform other Federal programs and State Medicaid programs; the team will iterate and fine tune the guide in FY24 Q2.

The team is also conducting on-the-ground design sessions to collect qualitative feedback from pilot sites, Alumni Navigators, and families.
Disseminate best practices and lessons learned among Healthy Start grantees or others interested in creating a Benefits Bundle in their communities, which will include a Benefits Bundle Playbook and training module.		In progress. The timing changed from FY 2023 Q4 to FY 2024 Q2. The project team, in collaboration with agency partners, developed a Benefits Bundle set of resources for pilot sites, which will eventually be made available to all Healthy Start grantees. This includes Medicaid and WIC refresher courses as part of training and onboarding materials for navigators, delivered in July.  These resources help Alumni Navigators understand what WIC and Medicaid are; understand the value each offers in meeting their family's needs; know what to expect when applying; know what documents to gather; and know where to apply for each program.  The team also worked with agency partners to develop Medicaid and WIC Pre-Enrollment FAQs, based on CMS and FNS input, to address top questions and challenges heard during the learning visits. In October 2023, the team delivered the first version of these resources to sites for their feedback and iteration.

## **Project Summary**

The Benefits Bundle aims to connect families welcoming a new baby to a bundle of supportive services through personal case management that is convenient, customized for language, and appropriately tailored to specific communities.

#### **Customer pain point:**

Families need help obtaining the correct information at the right time regarding eligibility, applications, and enrollment for existing services that can support them. Many families need help applying to programs due to burdensome processes, limited support on how to access information, disconnected systems, lack of coordinated and timely follow-through, or distrust in the government.

## **Project Objectives**

The Benefits Bundle will strengthen relationships across support systems to deepen health equity efforts in communities and ensure families are aware of and able to use services available at the Federal, State, local, Tribal, or territorial levels.

#### Target milestones in 2023 include:

- Readiness: Co-design and pilot the Benefits
  Bundle intervention in communities through
  approximately five pilots with HHS Healthy
  Start grantees to learn how to implement the
  intervention in a scalable manner.
- Momentum: Demonstrate the Benefits Bundle proof of concept and build the foundation for impact evaluations to be conducted.
- Capacity-Building: Disseminate best practices and lessons learned among Healthy Start grantees or others interested in creating a Benefits Bundle in their communities.

• Support: Build a model for future Federal approaches to Benefits Bundle supports.

## Primary deliverables in 2023 include:

- Benefits Bundle Playbook that outlines successful case studies for implementation of the pilot and describes how a community can launch its own Benefits Bundle
- Technical assistance and training for Healthy Start grantees

#### **Measures of Success**

#### **Key outcomes:**

By connecting families via personal case management with a Benefits Bundle of core public benefits programs and reducing barriers to accessing those programs and benefits:

- Families will have greater awareness of and easier access to public benefits (increase multiprogram enrollment of those that are eligible)
- Enrollment gaps in core birth to early childhood programs will shrink
- Maternal and caregiver stress will measurably reduce

## Design phase project measures:

- Deploy the Benefits Bundles in a small number of Healthy Start sites in States, Tribes, and/or territories
- Increase enrollment of eligible families in birth to early childhood programs
- Improve experience measures such as trust and satisfaction compared to the baseline
