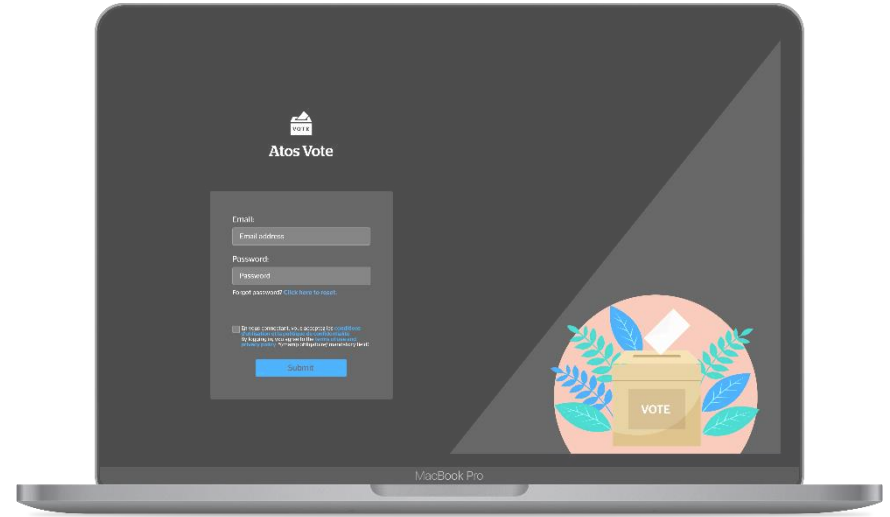


Steps to Access:

First, provide:

- o **Your shareholder number** (see in the next slide a sample of a voting instruction, and indication of where you can find your Shareholder number)

- o **Your family name**

We check that user is an authorized shareholder.

Second, your **email** is registered and your **password** is set-up.

From here, follow the same **log-in process** described in Steps **1** and **2**

Log-In – Voting Instruction Sample

Where to find your shareholder number?

As a registered shareholder, you have the possibility to transmit your instructions remotely, using the Atos Vote application, as well as to ask your questions live during the broadcasting of the General Meeting on the Internet, using a unique identifier required if your email address is not recognized by Atos Vote: this shareholder number, specific to this General Meeting, appears on the voting form attached to your invitation to the General Meeting received by mail.

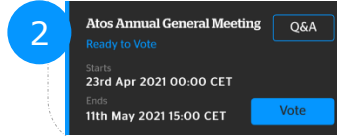

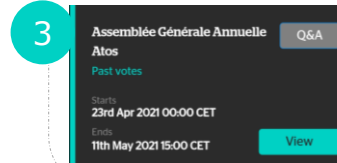
1. Register for the Upcoming voting event

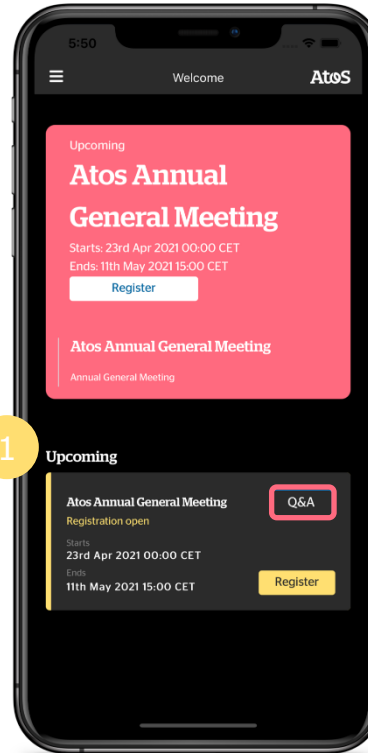

Mobile App Experience

Register

1. Click on the button "Register"
2. Automatic check will be run on the blockchain to approve access
3. Once approved you can vote for the specific event



User selects Register to run a check on Blockchain, ensuring they are in fact an approved voter for the meeting

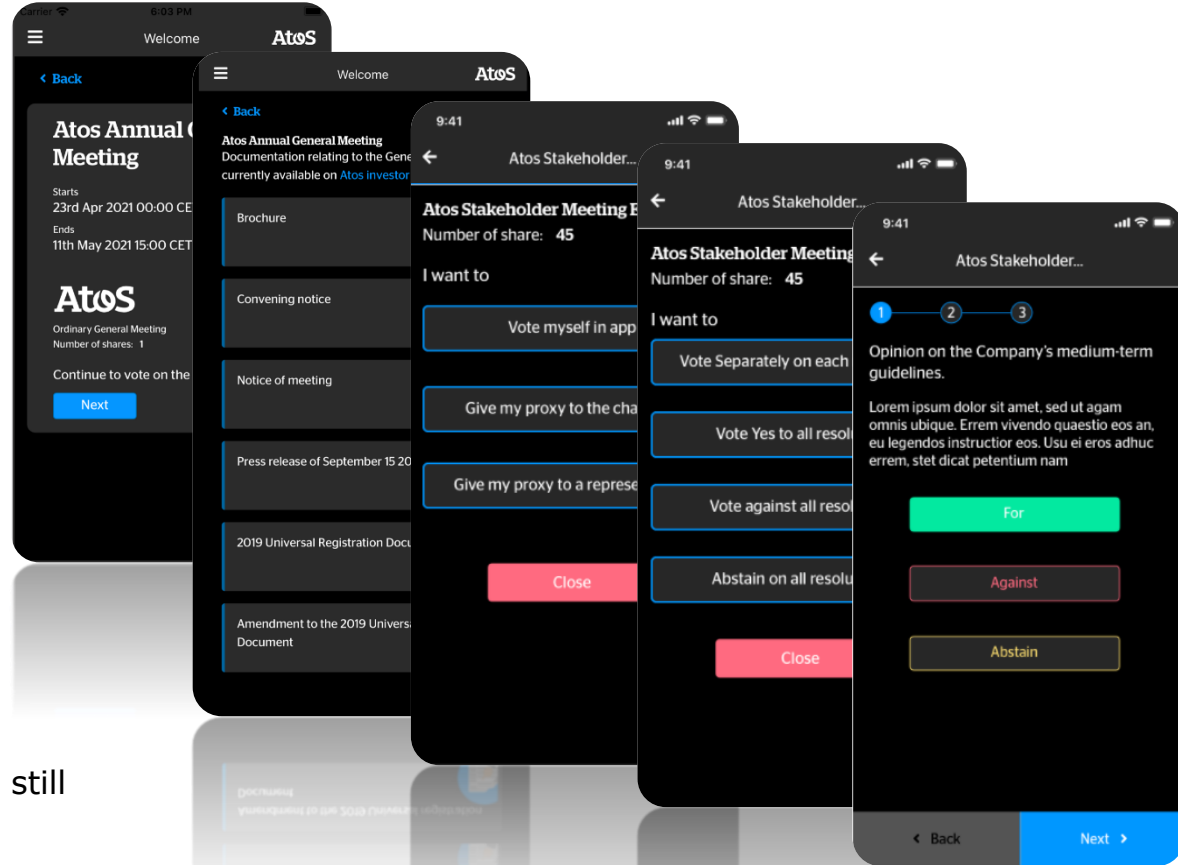
If the registration is not complete, Voter will not be able to progress with the next steps of voting.

If the user is not a registered voter, then they will be unable to access the features in the app to cast a vote.

Mobile App Experience

Vote

1. Complete the pre-voting selections in regards to how do you want to cast your vote:
 - a. By yourself in the app
 - b. Proxy to Chairman
 - c. Proxy to a Representative
2. If chose to vote personally (a), cast your vote for each resolution (in bulk, or individually) and review all your votes at the end, before final submission

After votes have been submitted, you will still always be able to view your past votes.

1. During Live AGM Meeting, the Q&A button will be enabled
2. You will be able to submit a Question to the Event Moderators. You can as well choose to submit your Question anonymously.
