I WANT TO FILE A COMPLAINT ...

Although the Attorney General is designated the chief law enforcement officer of the state, this office does not have jurisdiction or authority over any state or local government official or agency, or over the states attorneys and local law enforcement agencies; therefore, we cannot take complaints regarding those entities or individuals. In addition, this office is prohibited by law from providing legal advice or services to members of the public or private businesses. However, for convenience, we provide the following guide:

Attorney	If you feel your lawyer did a poor job, you may wish to discuss this concerns with your attorney
	before pursuing alternative methods of settling attorney-client disputes. If you feel the attorney
	acted unethically, contact the Supreme Court Disciplinary Board, (701) 328-3925.
Bank	Department of Financial Institutions, (701) 328-9933
Bids, public entity	File a complaint with the public entity that issued the bid, or contact an attorney.
Child Support	Department of Human Services Child Support Enforcement, (701) 328-3582, or an attorney.
City/County Commissioner	A city or county commissioner is an independently elected local government official. The Office of
	Attorney General does not have jurisdiction over local government entities or officials and cannot
	take a complaint. Make your complaint to the elected official. See also: Local Government.
Civil Rights Violation	American Civil Liberties Union, or an attorney in private practice.
Collection Agency	You have rights under the <i>federal</i> Fair Debt Collections Practices Act. If you believe a collection
	agency has violated those rights, file a complaint with the federal Consumer Finance Protection
	Bureau (see <u>www.consumerfinance.gov</u>).
Contract, Breach of	Contact a private attorney for legal advice or enforcement options.
Contractor	If the job is valued at \$4,000 or more, the contractor must be licensed by the Secretary of State. If
	a contractor is not licensed, report it to the Secretary of State's office at (701) 328-2900, or to the
	Attorney General's Consumer Protection Division, (701) 328-3404. If you have paid advance
	money to a contractor but the contractor has not done any work or not finished the job, contact
	the Consumer Protection Division.

Discrimination	Alleged discrimination in employment, housing, public accommodations, public services, and
Decrete Decre Sales	credit/lending contact the Department of Labor, (701) 328-2660, or an attorney.
Door to Door Sales	Transient merchants must have a state license and may also be required to obtain a city permit. Call the Consumer Protection division at (701) 328-3404, or local law enforcement.
Elected Official	An elected public official is not subject to the jurisdiction of the Office of Attorney General. Your
Liected Official	complaint should be directed to the elected official.
Elections	Contact the county auditor or the Secretary of State's office, or go to vote.nd.gov.

	Attorney General's website, <u>www.attorneygeneral.nd.gov</u> .
Employment	ND Department of Labor, (701) 328-2660.
Federal Agency	Contact the head of the federal agency or North Dakota's Congressional delegates.
Fraud, local business	Attorney General's Consumer Protection Division at (701) 328-3404.
Fraud, Government	See Misuse of Public Funds.
Gas Prices	See <i>Price Gouging</i> , or contact the ND Petroleum Marketers Association at (701) 223-3370.
Government Employee	To complain about a government employee (city, county, public school, state, federal), contact
	the employee's supervisor or the head of the agency.
Insurance Agent	ND Insurance Commissioner, (701) 328-2440.
Judge	A judge is an elected official. The Office of Attorney General does not have jurisdiction or
	authority over elected officials and cannot take a complaint. If your complaint relates to a judge's
	decision or ruling on a case, contact an attorney to discuss options for appeal.
Land Rights	We do not have jurisdiction over transactions relating to lease or sale of oil, gas, mineral, or wind
	rights, or royalty payments, and cannot take a complaint or review contracts. Contact an
	attorney.
Land Sales	We cannot take a complaint about a real estate transaction or review contracts. Contact an
	attorney.

Complaint	Referral Information
Landlord	We cannot take a complaint. General information is at www.attorneygeneral.nd.gov. For
	assistance, contact Legal Services of North Dakota, (800) 634-5263, or an attorney.
Liens	The Office of Attorney General does not have jurisdiction over lien filings. Contact an attorney.
Licensed Professional	(e.g. realtor, accountant, doctor, etc.), contact the state regulatory board or commission. Contact
	information for State Boards is available at <u>www.governor.nd.gov</u> .
Local Government	Local government: city, township, county, park board/district, school board/district. The Office of
	Attorney General does not have jurisdiction over local government entities or officials and
	therefore cannot take a complaint. If you disagree with the decisions or actions of a local
	government entity, official, or employee, contact the members of that entity's governing body, or
	consult an attorney.
Marsy's Law	The Office of Attorney General cannot take complaints of alleged violations of a victim's rights
	under Marsy's Law. Contact the prosecuting attorney's office, or your own attorney.
Misuse of Public Funds	(1) By a political subdivision (such as a city/county government entity, park district, public school
	district): report it to the local law enforcement agency having jurisdiction. (2) <i>By a state entity</i> :
	report it to the ND Office of Management and Budget, or the State Auditor, or the ND Highway
	Patrol. (3) By an employee of a political subdivision or state entity: report it to the head of the
	agency, or local law enforcement.
Pawn Shop	Pawn Brokers are licensed by the Department of Financial Institutions, (701) 328-9933, and the
	city in which they are located. Certain complaints may also fall under the authority of the

Payday Loans	Department of Financial Institutions, (701) 328-9933.
Police Chief/Police	The city police department is a local government agency. The Office of Attorney General does not
Department	have jurisdiction or authority over local government agencies and cannot take a complaint about
	a police chief or police department; complaints about the way the department is operating should be directed to the Chief of Police or the city commissioner who handles the Police portfolio.
Police Officer	The officer's supervisor or the Chief of Police.
Price Gouging	There is no state law restricting the amount of profit a retailer can set for gasoline or any other
Price doughing	retail product; therefore, a retailer can charge any price he wants over wholesale. Because there
	is no state law restricting or limiting retail prices, this office cannot take a complaint.
School Board/District	School board members are elected. Complaints should be directed to the individual member.
School Bouldy Bistrict	Complaints about a school district should be directed to the district, or contact an attorney.
Sex Offender	Information about registered sex offenders is at www.sexoffender.nd.gov. If you have concerns
Jek Gilender	about a specific offender or public notification about an offender, contact the local law
	enforcement agency in the jurisdiction where the offender resides.
Sheriff or Sheriff's	
Department	jurisdiction or authority of the Attorney General or any other state agency. The Sheriff is the head
•	of his agency; complaints should be directed to the Sheriff.
Sheriff's Deputy	The deputy's supervisor, or the Sheriff
State Agency	The Attorney General does not have authority over any other state agency, board, or commission,
	and cannot take a complaint. Make your complaint directly to the agency head.
State's Attorney	The state's attorney is an independently elected local government official not subject to the
	jurisdiction or authority of the Attorney General or any other state agency. By law, a state's
	attorney has "prosecutorial discretion" to decide whether to file charges and which cases to
	prosecute. The Attorney General cannot overrule the state's attorney. Your complaint should be
	directed to the state's attorney. If the State's Attorney has declined to prosecute a case, you may
	wish to contact an attorney to discuss civil options.
Township	This office does not have authority over township officials. Direct your complaint to the township
	official, or contact an attorney.
Unpaid Wages	Department of Labor, (701) 328-2660
Whistleblower	Whistleblower complaints can be filed with the government agency that is the subject of the
	complaint, the county state's attorney, or the Office of Attorney General. The Attorney General
	does not represent the employee nor can we initiate an investigation of the complaint. For legal
	advice, contact an attorney.
Workforce Safety &	Direct the complaint to Workforce Safety & Insurance. The Office of Attorney General does not
Insurance (WSI)	have authority over WSI. For legal advice, contact an attorney.
