

## Revision to the Consolidated Credit Card Terms (“Terms”) effective 1 April 2023

Kindly be informed of the following revisions to the Consolidated Credit Card Terms effective **1 April 2023**:

1. For **Priority Banking Visa Infinite** credit card:

Clause	Previous	Revised
6.10	Principal Cardholders are entitled for complimentary access to airport lounges <del>which is unlimited as long as</del> you maintain your Priority Banking membership with minimum Asset Under Management (“AUM”) of <del>RM250,000</del> .	Principal Cardholders are entitled for <b>unlimited</b> complimentary access to airport lounges <b>with one complimentary accompanying guest access per visit</b> if you maintain your <b>Priority Private</b> membership with minimum Asset Under Management (“AUM”) of <b>RM3,000,000</b> .
6.11	Your complimentary access to airport lounges will be limited to the first <b>2</b> visits <del>annually if your Priority Banking membership has ended or if you do not maintain the required minimum AUM of RM250,000</del> .	Your complimentary access to airport lounges will be limited to the first <b>8</b> visits <b>per calendar year</b> if you maintain your <b>Priority Banking</b> membership with minimum Asset Under Management (“AUM”) between <b>RM250,000 to RM2,999,999</b> .
6.12	For the avoidance of doubt, to enjoy complimentary <b>unlimited</b> access, you must maintain your Priority Banking membership with minimum AUM <del>of RM250,000</del> in the same month you access the airport lounge otherwise you will be charged for the access <del>after you have utilised the 2 times complimentary access</del> .	For the avoidance of doubt, to enjoy complimentary access, you must maintain your Priority Banking <b>or Priority Private</b> membership with minimum AUM <b>set out in clause 6.10 and 6.11</b> in the same month you access the airport lounge otherwise you will be charged for the access.
6.14	A charge of <del>USD27</del> per person per visit will be debited to your <i>Priority Banking Visa Infinite credit card</i> account for: <ul style="list-style-type: none"> <li>(a) Each access exceeding the Cardholder’s airport lounge complimentary access</li> <li>(b) Each accompanying guest of Cardholder to airport lounge</li> <li>(c) Each access of using Supplementary Priority Banking Visa Infinite credit card</li> </ul>	A charge of <b>USD29</b> per person per visit will be debited to your <i>Priority Banking Visa Infinite credit card</i> account for: <ul style="list-style-type: none"> <li>(a) Each access if your <b>Priority Banking</b> membership has ended or if you do not maintain the required minimum AUM of <b>RM250,000</b></li> <li>(b) Each access exceeding the Cardholder’s <b>eligible</b> airport lounge complimentary access</li> <li>(c) Each accompanying guest of Cardholder to airport lounge</li> <li>(d) Each access of using Supplementary Priority Banking Visa Infinite credit card</li> </ul>
6.16	Cardholder is required to present Priority Banking Visa Infinite credit card, Boarding Pass and mention “LoungeKey” when visiting participating airport lounge of LoungeKey.	<b>Airport lounge access service is provided by LoungeKey</b> . Cardholder is required to present Priority Banking Visa Infinite credit card, Boarding Pass and mention “LoungeKey” when visiting participating airport lounge of LoungeKey.
