Privacy Policy

This Privacy Policy ("Policy") applies to https://www.smes.org, and St. Margaret's Episcopal School ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include https://www.smes.org, Breakthough San Juan Capistrano and https://www.breakthroughsjc.org. The Company's website is a Education Institution site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- -First and last name
- -Mailing address
- -Email address
- -Phone number

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

The Company collects and uses your personal information in the following ways:

- -to carry out the Company's obligations and enforce our rights arising from any contracts ente

The Company may also use your personally identifiable information to inform you of other

Sharing Information with Third Parties

The Company does not sell, rent, or lease its customer lists to third parties.

The Company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to the Company, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

The Company may keep track of the websites and pages our users visit within the Company, in order to determine what the Company services are the most popular. This data is used to deliver customized content and advertising within the Company to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

The Company may automatically collect information about your computer hardware and software. This information can include your IP address, browser type, domain names, access times, and referring website addresses. Use of Cookies

The Company's website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- -Comply with the California Electronic Communications Privacy Act;
- -Engage in public or peer-reviewed scientific, historical, or statistical research in the public in
- -Enable solely internal uses that are reasonably aligned with your expectations based on your
- -Comply with an existing legal obligation; or
- -Otherwise use your personal information, internally, in a lawful manner that is compatible wi
