MINUTES OF THE SOUTH DAKOTA ANNUAL WEED & PEST CONTROL COMMISSION MEETING 2 Wednesday, February 21, 2024 – 1:30 pm MT Spearfish Holiday Inn – Convention Center, Spearfish, SD

Chairman Darwin Kurtenbach called the meeting to order at 1:30 pm, February 21, 2024.

Members Present: Commissioners Dennis Feickert, Chuck Anderson, Deb Schultz, Bruce Helbig, Darwin Kurtenbach, Game Fish & Parks representative Ryan Wendinger, Association of SD County Commissioners Representative Lynn Deibert; Department of Transportation Representative Christina Bennett; School and Public Lands Commissioner Brock Greenfield; Non-Voting Member - SDSU Representative Eric Jones; SD Department of Agriculture & Natural Resources Representative Bill Smith; and Commission Secretary and Plant Industry Program Manager Brenda Sievers.

Dennis Feickert made a motion to approve the agenda. Seconded by Brock Greenfield. Motion carried.

Chairman Kurtenbach asked for any changes to the minutes from the December 13, 2023, meeting. A motion was made by Brock Greenfield to approve the minutes. Seconded by Chuck Anderson. Motion carried.

No old business presented.

New Business

Discussion was held on the locally noxious weed requests. Brock Greenfield made a motion to approve those locally noxious requests that were renewals or already on the list for locally noxious weeds. Seconded by Ryan Wendinger. Motion carried.

Discussion was held on the request for adding waterhemp as a locally noxious weed in Bennett County, which would require a rules hearing to make the addition. Brock Greenfield made a motion to deny listing waterhemp as a locally noxious weed. Seconded by Deb Schultz. Motion carried.

Discussion was held on the request for adding baby's breath as a locally noxious weed in Fall River County, which would require a rules hearing to make the addition. Lynn Deibert made a motion to add baby's breath as a locally noxious weed. Seconded by Bruce Helbig. A roll call vote was held – Bennett – no; Anderson – no; Deibert – yes; Schultz – no; Feickert – no; Helbig – yes; Greenfield – no; Wendinger – no. Motion failed - 6 no and 2 yes.

Deb Schultz made a motion to deny Fall River's request to add baby's breath as a locally noxious weed in their county. Seconded by Chuck Anderson. Motion carried.

The Weed and Pest Coordinator Report was given by Brenda Sievers. Weed and Pest Staff set up and assisted at the Association of SD County Weed and Pest Board booths at Sioux Falls Farm Show, Black Hills Stock Show, and Watertown Farm Show. With the retirement of Dale Anderson, the Program Specialist position to coordinate the CAPS (Cooperative Agricultural Pest Surveys) program has been advertised, with interviews to be conducted soon. Sievers also gave an update on the survey work planned for 2025.

Jeremiah Phelps, Weed and Pest Program Specialist, gave a report on shows he assisted at, as well as gave a bio control update.

District reports were given by:

District 1 Representative Dennis Feickert - attended District Weed Meeting in Brookings and feels counties are struggling financially,

District 2 Representative Darwin Kurtenbach - had great crops in his area, but common mullein is starting to come in, hopes to attend annual weed meetings,

District 3 Representative Bruce Helbig - has seen an increase in the red seed head weevil in sunflowers and the four-county annual weed meeting will be March 18th in Harold,

District 4 Representative Chuck Anderson - been a cold winter but now in a dry spell, grasshoppers ate much of the leafy spurge and Canada thistle in 2023, and

At Large Representative Deb Schultz reported this was her first meeting and looking forward to more.

Agency reports were given by:

School and Public Lands Commissioner Brock Greenfield – grasshoppers were sprayed by lessees, as well as thanked counties for the work they do, as it is appreciated;

Game, Fish and Parks Representative Ryan Wendinger – sprayed 12,000 acres in 2023 but many low areas dried up so will be interesting to see what weeds it brings, also appreciates the county's work;

Department of Transportation Representative Christina Bennett – spent \$2.5 million on weed spraying in 2023 and the state bid amount has increased to \$50,000.

SD Department of Agriculture and Natural Resources Representative Bill Smith reported on the good neighbor authority as well as forest service assessments. They will have joint powers agreements with affected counties. Conservation Commission will meet on April 10th.

Association of SD County Commissioners Representative Lynn Deibert reported there was no late fall chemical spraying done in his area.

USDA APHIS PPQ Representative Mike Stenson reported on spongy moth trapping as well as the grasshopper assistance program. They are having difficulties getting seasonal employees hired.

SDSU Representative Eric Jones asked to give his report during the grant update.

Chairman Kurtenbach announced it was time for the public comment period.

SD Department of Agriculture and Natural Resources Plant Industry Program Manager Brenda Sievers reported that the district weed meetings held each November would be discussed by the Association of SD County Weed and Pest Boards at their board meeting. The Association has hosted those meetings, but typically staff from SDSU and the Department of Agriculture and Natural Resources put together the programming. It is the intention of the Association to not hold those meetings anymore and the Department supports that change.

Pennington County Weed Supervisor Scott Guffey received a prairie dog complaint on Bureau of Land Management property north of Wall for encroachment onto private property. According to SDCL 38-22-17.2, the county can request the SD Weed and Pest Control Commission to assist with the enforcement, should it be necessary if BLM doesn't do control.

Chairman Kurtenbach declared a break at 2:47 pm.

The meeting resumed at 3:15 pm.
