Please indicate at the top of the application which type of registration you are filing.

- Item 1.** Enter the complete name of the farm, ranch, estate or villa.
- Item 2.** Enter the county where the farm, ranch, estate or villa is located.
- Item 3.** Enter the complete address of the farm, ranch, estate or villa.
- Item 4.** Enter the complete name of the registrant (owner and/or lessee) of the farm, ranch, estate or villa.
- Item 5.** Enter the relationship of the registrants (owners and/or lessees), if there is more than one owner of the farm, ranch, estate or villa.
- Item 6.** Date and sign the registration. If there is more than one owner and/or lessee of the farm, ranch, estate or villa, the partner(s) or spouse is required to sign.
- Item 7.** Enter the name and address of the person or firm to receive the acknowledgment of the filing.
