Annual Project Selection - a program supporting small and medium sized organizations promoting social change in communities across Brazil. Projects are selected through a call for proposals in the areas of education and culture, health, human rights, socioeconomic development and civic participation. Grantees are monitored and evaluated throughout the grant cycle. BrazilFoundation conducts site visits and offers mentoring and training to the leadership of each funded organization, to maximize the impact of the grants. Additionally, BrazilFoundation conducted a special assessment of its first 10 years of grant making and invited 20 past grantees to participate in a special project focused on organization history, systemization of social technologies and results evaluation, which was published in a book.

Programmatic Partnerships - BrazilFoundation partners with corporations and institutions seekin to strengthen their social investment.
