Donor advised grants to various organizations in Brazil working to promote education, health, human rights and socioeconomic development. Following diligent review of recommended organizations, Brazil Foundation channels resources to selectd organizations. Grants are listed on schedule F, part II, pages 1 and 2. Main accomplishments: 32 organizations received institutional support.

4b (Code:) (Expenses \$ 358,990 including grants of \$ 745,123) (Revenue \$ 1,139,678)

Discretionary grantmaking and capacity building - a program supporting small and medium sized organization promoting social change in communities across Brazil. Projects are selected through a call for proposals in the areas of education and culture, health, human rights, socioeconomic development and civic participation. Grantees are monitored and evaluated throughout the grant cycle. Brazil Foundation conducts site-vists and offers mentoring and training to the leadership of each funded organization, to maximize the impact of the grants. Main accomplishments: 102 organizations received funding, 35,000 people directly benefited, 175,000 people indirectly impacted.

Programmatic partnerships -Brazil Foundation partners with corporations and institutions seeking to strengthen their social investment. The foundation provides training workshops to project leaders of organizations financed by other institutions in the areas of management and communication, project monitoring and evaluation and sustainability. Brazil Foundation also advises on grantee selection, and provides support on monitoring and evaluation. Through partnerships with CSP, Instituto Votorantim and Tyco, grants to 7 organizations were provided.
