Main accomplishments: 23 organizations in 7 states received institutional support.

Discretionary and Partnership grants - a program supporting small and medium sized organization promoting social change in communities across Brazil. Projects are selected through calls for proposals in the areas of education and culture, health, human rights, socioeconomic development and civic participation. Grantees are monitored and evaluated throughout the grant cycle. Main accomplishments: 81 organizations in 18 states received funding, 29,299 people directly benefited.

Program Support - Brazil Foundation conducts site-visits and offers mentoring and training to the leadership of each funded organization, to maximize the impact of the grants.
