CALIFORNIA MICROBUSINESS COVID-19 RELIEF GRANT PROGRAM

PROGRAM OVERVIEW

The California Microbusiness COVID-19 Relief Grant is administered by the California Office of the Small Business Advocate (CalOSBA). The Program provides competitive micro grants of \$2,500 to eligible microbusinesses impacted by COVID-19 and the related health and safety restrictions. Amounts available for each County were based on population and determined by the latest population estimates from the California Department of Finance. The role of grantmaking entities was granted to County government agencies or a consortium of nonprofits through two rounds of applications.

The Microbusiness COVID-19 Relief Grant round 1 was launched on May 17, 2022, and ended on October 19, 2022. After reviewing the number of awards, Chabot-Las Positas Community College District (CLPCCD) decided to start round 2 on January 18 and ended it on April 2, 2023. CLPCCD partnered with Southwest Community College District's Small Business Development Center (SBDC) to help administer the grant program and provide technical assistance. The application was created by SBDC to protect against fraud, waste, and abuse while making the application process as simple as possible. Marketing material was created in five languages, English, simple Chinese, Tagalog, Vietnamese, and Spanish. The website was launched with collateral posted online.

CLPCCD's outreach team held Zoom webinars and in person training events for partners in Alameda County. CLPCCD connected with County Supervisors office answering questions and encouraging their help contacting their microbusinesses. Social media ads were created and boosted on Facebook and Instagram. CLPCCD worked with 4 external partners for outreach to deliver material to targeted areas via e-mail, social media, and hand delivery of the flyers. Time was spent with the Regional Partners making sure their questions were answered so they could get the word out. Webinars were hosted for the business groups and partner's support. Communication and collaboration ensued with partners to assist applicants and encourage them to apply. Interviewed and prepped partner for Telemundo, Channel 5 new broadcast.

From the start of the Microbusiness Grant application process dated May 17, 2022, through June 15, 2023, Alameda County had 1,979 applicants with 712 paid, and 1,267 denied. Of the 715 available grants, CLPCCD was able to award 712.

KEY OUTREACH ACTIVITIES:

3CORE has continued to provide information on the CA Microbusiness COVID19 Relief Grant program to partner groups and organizations throughout this reporting period. 3CORE staff have also attended various community events throughout Butte County to provide information about the program to possible eligible applicants. This information has been provided in Spanish, English and Hmong, including program flyers as a leave behind.

Events where outreach has taken place during this reporting period include presentations on the program at various chamber mixer events that took place in the town of Paradise, Chico, and Oroville. One of the events was sponsored by the North State Hispanic Chamber, where the presentation was provided in Spanish, for the primarily Spanish speaking business owners in attendance.

To date, the partner organizations that 3CORE has provided this information to in Butte County include:

- The North State Hispanic Chamber of Commerce
- The Town of Paradise
- Butte County Administration
- Team Chico, which includes the Chico Chamber of Commerce, City of Chico, Alliance for Workforce Development (the local workforce development provider), Butte College The Training Place, Butte College Small Business Development Center, CSU Chico, The Downtown Chico Business Association, Explore Butte County, and the North State Planning and Development Collective.

3CORE staff, in partnership with the North State Hispanic Chamber of Commerce have provided information to minority owned businesses in Butte County by visiting with business owners in-person and providing technical assistance, as needed, for them to apply. This includes sitting down with the business owner and completing the application with them on a laptop. The Hispanic Chamber also provided information by periodically conducting live interviews in Spanish via their social media platforms. Interviews have included 3CORE staff providing information on the CA Microbusiness Grant Program.

KEY OUTREACH ACTIVITIES:

During the months of March 14th through June 8th, Imperial Valley Small Business Development Center staff reopened the Microbusiness COVID-19 Relief Grant Application and restarted marketing through the following methods: social media ads (English and Spanish), email newsletters, and community events, in order to reach the goal of awarding 78 microbusinesses.

Interested microbusinesses were asked to set up a one-on-one meeting with staff so that the eligibility requirements could be explained and, if determined a good fit, to assist with submitting documents within their online application.

Over the last few months, a total of 50 applications were received and 42 grants were awarded by the County of Imperial. After awarding 36 from the first round of openings from September through November 2022, the last 42 awards allowed the County of Imperial to reach the goal of serving 78 eligible microbusinesses in Imperial County.

KEY OUTREACH ACTIVITIES:

Employers' Training Resource (ETR) held regular meetings to discuss potential ways of outreach that could boost application numbers throughout the life of the grant and as the end of the program approached. At a meeting held April 24, 2023, ETR addressed the continuation of advertising the grant on Radio and TV spots. On May 10, 2023, ETR spoke with the marketing team to push the program weekly to further the reach to potential applicants to ensure the goal was met. ETR continued to receive a boost in applications in March, April, and May due to the spread of information regarding the funding from previously approved applicants. Word of mouth continued to be the most effective form of outreach for this grant. ETR reached its goal of 369 approved applications on Tuesday, May 16, 2023. ETR met with the partners to finalize the last funding rounds and final invoices on May 30, 2023.

Kern Women's Business Center (KWBC) continued to receive an influx of potential clients from the Vietnamese community because of a past applicant who spread the news via word of mouth. KWBC continued to hold appointments for clients to assist them with filling out the application and ensuring that they submitted the correct documents. They completed the program with 168 approved applications.

The Community Action Partnership of Kern (CAPK) assisted potential applicants on the phone, by email, or through walk-ins, by providing them with the application and answering questions potential participants had about the required documents. They also used the additional staff in outer-lying areas of the county with their outreach efforts to make a final push for the last few months of the program. They completed the program with 82 approved applications.

Kern Economic Development Foundation (KEDF) was available via email, phone calls, and walk-ins for applicants to ask questions and drop off their applications. In the last quarter, KEDF focused on preparing and mailing funding rounds so the applicants would receive funding as soon as possible. They completed the program with 56 approved applications.

During its weekly Wednesday webinars, the Small Business Development Center (SBDC) promoted the Microbusiness Grant virtually. SBDC also provided clients with applications and assisted them with any questions regarding their applications on the phone and by email. They also shared information about the program at the Kern Women's Business Conference in April 2023. They completed the program with 63 approved applications.

Lake County Economic Development Corporation's (LCEDC) efforts and initiatives aimed at informing and assisting businesses in Lake County to take advantage of the Microbusiness COVID-19 Relief Grant. LCEDC utilized various communication channels to reach out to the county's businesses. These channels included:

The successful applicants were able to leverage the financial support received from the grant to help overcome the challenges they endured due to the pandemic and sustain their businesses.

LCEDC received 31 grant application and awarded eight (8) grants to Lake County's local microbusinesses.

Sierra Business Council (SBC) created buzz and anticipation amongst community partners in the four-county region about the Microbusiness COVID-19 Relief Grant Program. There was much interest in the program when SBC was initially collecting partnership agreements, so when the program went live, their focus was on reengaging those partners through direct email, newsletter blasts, phone calls, and social media. The program has been announced multiple times throughout the Sierra Business Council e-news blast, which has a reach of over 2,500 readers.

SBC released a partner toolkit, in both English and Spanish, for all 12 partners to utilize. This includes newsletter copy, flyers, social media graphics, and social media language examples.

The program was able to fully expend funding in Plumas, Modoc, and Sierra Counties.

Despite over 65 hours of technical assistance, outreach, and reporting for this program, Lassen County was not able to fully expend its allocation. In February, Sierra SBDC sent an e-news blast specifically to 31 clients of the SBDC alerting them to the grant opportunity.

In May, Sierra SBDC staff identified a community leader and met with them about the program. This person was able to share the contact information of other small businesses in the region that had been impacted by COVID-19, and SBC was able to grant 5 additional grants. This includes a hairstylist who was unable to apply for any other relief funding due to technical challenges. SBC staff walked her through every step of the application so that she was finally able to access a grant to help her recover!

The application process for all four counties launched May 31st and closed on June 30th and Plumas County received 18 applications, with 9 eligible, so the program closed.

On July 6th, the application process for Modoc, Lassen, and Sierra counties re-opened on a first-come, first-served basis.

Plumas County received 18 applications, only 9 were found eligible and the application is fully allocated and now closed.

Sierra County received three applications, one was eligible. Program is closed.

Lassen County received 10 applications, 9 are eligible. Program is closed.

Modoc County received 5 applications, one was ineligible. Program is fully allocated and closed.

At the start of the program, Madera County partnered with four community-based organizations (CBO's) to provide outreach in the community. The four CBO's included: Community Action Partnership of Madera County, Madera Chamber of Commerce, Madera Coalition for Community Justice, and Madera Workforce. These four CBO's were strategically selected as they work with underserved communities and individuals on a daily basis. The CBO's informed those they serve about the Microbusiness COVID-19 Relief Grant Program (MBCRG) Program, when applicable. Flyers were provided for distribution to each of the four partners in both English and Spanish. These flyers were posted on each of the CBO's front desks and community boards and distributed to the individuals they serve.

The website page launched on March 10, 2022 and has now been removed as the program came to an end. The website contained information for the program which included guidelines, requirements, application form, and FAQs. The website page was an asset from the start of the program as it contained all relevant information in one place. Madera County Economic Development Commission (MCEDC) offered support to non-English speakers through their bilingual staff.

Various outreach strategies were implemented. MCEDC reached out to microbusinesses that received a grant from the County's CARES Small Business Assistance Program from 2020, that could potentially qualify for this program. MCEDC also shared Microbusiness COVID-19 Relief Grant Program information with those applying to the County's ARPA Small Business Assistance Program, that could also potentially qualify for the Microbusiness Grant Program. Unfortunately, very few that applied for the County's ARPA Small Business Assistance Program met the requirements for the MBCRG Program.

Media engagements consisted of Facebook posts on the County of Madera page, the MCCJ page, the CAPMC page, the MCEDC page, and the Madera Workforce page. MCEDC included information about the program on their monthly e-newsletter.

Presentations were given at Chamber Mixers in both Ukiah and Willits, MAC meetings and any opportunity that EDFC had a audience. Staff worked with local tax preparers and a Hispanic Business Center in effort to reach home based businesses. Tables were set up at the local Farmer's Market and flyers were shared. Although the goal of funding 35 grants was not reached, EDFC feels they made an impact and are pleased with the results. Staff spent countless hours working with applicants in gathering the required documentation to determine eligibility.

In the end, Merced County secured 111 microbusinesses awarded through the program – this assisted in their day-to-day operational needs and allowing the owners and operators an opportunity to continue their business during these trying times. Merced County is now in the final stages of processing the last awards to close the program successfully. At the program's conclusion, Merced County will update the website, informing the community that those who have received the grant funds will contact the office for 1099 questions and documents and a flyer that will be shared with the community letting residents know the program is now closed.

OUTREACH

The resources Monterey County Workforce Development Board (MCWDB) developed include the application, flyers, PowerPoint presentations, live recordings of the informational webinars, and frequently asked questions (FAQs) in both English and Spanish. A dedicated webpage was also created that includes a widget to enable translations to other languages. Both the MCWDB team and partners conducted outreach in-person and online through email blasts to various distribution lists, social media posts, and door-to-door visits. All partners were required to report their outreach efforts to the MCWDB team via an electronic form on a regular basis. Doing so allowed the MCWDB team to not only understand what businesses were being reached and where, but also for them to be able to cross-reference with their applicant database later to identify what percentage of those contacted had applied and been awarded.

TECHNICAL ASSISTANCE

Technical assistance was available in both English and Spanish and included a walkthrough of the program requirements and help with submission of the application. The MCWDB team and partners were available to applicants for assistance via email, telephone, and in-person. After an application was submitted, communication between the MCWDB team and the applicant was done primarily via email to not only provide confirmation that their application was received, but to also send ongoing updates and ultimately notify them of their award status. Additional assistance was also given, in the event an application was missing one or more of the required documents. The intent of doing so was to ensure that each applicant fully understood what was required and had an opportunity to submit what was missing, should there have been a translation miscommunication the first go-round. To assist the MCWDB team with tracking applicant data and reviewing applications for eligibility, an internal database and application review process were also established.

One of the MCWDB partners was in communication with a community leader to collaborate on a special event in Kings City on April 18, 2023, whereas microbusiness owners had the opportunity to learn about the eligibility criteria, ask questions, and submit applications. MCWDB staff was present to help ensure that all the required documents were submitted and began processing the applications in real time. All the approved applications received from this event and others up until the application period closed received their checks in-person to prevent any receipt issues via posted mail.

KEY OUTREACH ACTIVITIES:

Throughout the course of the program, the Orange County Workforce and Economic Development Division (OCWEDD) partnered with the Cities, Chambers of Commerce, Public Libraries, and other organizations throughout Orange County to provide outreach for the program. In efforts to better reach the target demographics, Orange County CEO Executives conducted a social media campaign by sharing the program on all social media platforms. The board members also assisted by sharing the program with their networks. In addition to those techniques, OCWEDD utilized social media platforms, website, local newspapers, and local televised news outlets (Telemundo) to share information on the program. OCWEDD staff contributed to the distribution of information by sharing flyers during regional meetings, business events (such as SBDC Conferences), and by conducting monthly informational virtual webinars to answer any questions regarding the application and program. Through these efforts OCWEDD received 3,913 applications and were able to distribute the allotted funds to 1,470 eligible Microbusiness who were impacted by COVID-19.

OCWEDD continues to provide live support to applicants and awardees during normal business hours through the Economic and Business Recovery call center with translation services available to callers in more than 240 languages. Through the course of the program the call center has assisted applicants and awardees with technical issues, questions on the application, and continues to be the main point of contact for awardees.

In addition to the outreach strategies mentioned above, street canvassing was performed by program staff in Orange County neighborhoods handing out flyers to sidewalk vendors. The County's libraries, Workforce Solutions Center and Mobile One-Stop center were all made available to applicants to provide access to the application site if needed.

KEY OUTREACH ACTIVITIES:

Placer County and its partners engaged in a widespread outreach campaign to ensure that the MBCRG program was being distributed across the entire county and especially to reach the underserved, smallest businesses in the county. Prior to opening Rounds One and Two of the program, the County entered into an intensive County-wide marketing effort that included Spanish language radio ads, earned media, press releases, and more. Additional rounds of radio ads went live in the early part of 2023. The program has now closed as of June 2nd, 2023.

In preparation for program closing, the County and its partners entered into a final outreach effort with the marketing “last chance” and were able to receive a number of new applications through this outreach strategy. The metrics for that newsletter are below. In addition to the newsletter, staff presented once again at multiple partner meetings with the same “last chance” marketing language.

Sierra Business Council (SBC) and County staff worked many different outreach strategies to reach the underserved business community of Placer County over the past year plus. The final result is nearly a full allocation of grant funding for this program. The grants received by the microbusinesses we were able to reach are deeply appreciated by the recipients.

Throughout the entire application, Sierra Business Council staff provided have provided all of the technical assistance necessary to applicants. This included over 150 hours of direct, technical assistance for the program from 2/1/22 to 6/5/23 by staff and Small Business Development Center advisors. Many applicants required assistance gathering documentation to prove that the business was in operation in 2019 and provide an explanation of revenue that meets the required \$50,000 limit. SBC’s technical assistance includes phone calls, zoom meetings, and emails.

SBC staff reviewed eligibility quiz results and application submittals daily to ensure that no mistakes were made. SBC took care to contact applicants where errors were clear, and communicate quickly with applicants found ineligible to ensure no mistakes were made. As of 6/30/23 SBC has received 204 applications, of which 131 are eligible. As displayed in our performance metrics, we did receive a large number of applications that appear to be fraudulent.

The County of Riverside Office of Economic Development (RivCoED), MBCRG program community partners, outlined below, and additional county partners across the county continue to collaborate to provide outreach and technical assistance for the MBCRG program. RivCoED and community partners have continued to promote the program in newsletters and on social media platforms as well as with city and chamber partners countywide to include the county's Hispanic Chambers of Commerce. All social media marketing and print materials have been produced in both English and Spanish.

Media buys ran from early May till the end of June with three radio stations, two of which were Spanish language radio. Over 850,000 total radio campaign impressions were made through the radio advertising schedule. Additionally, RivCoED staff did eleven on-air radio interviews as well as two TV news station interviews with KESQ (ABC affiliate - English) and Telemundo (Spanish) about the MBCRG program. Advertising funds were fully expended in June 2022, no additional paid media buys were made past that point.

Starting again in January 2023, Riverside County staff continued with a heavy push of the program with Community-based and countywide partners. RivCoED staff, the Coachella Valley Small Business Development Center (CVSBDC), and other community partners continued to promote the program on a regular basis via consultants' 1:1 appointments, events, office incoming calls, initial intakes, and any opportunity that might seem fit to mention the program. In the last 90 days, RivCoED attended several special events to where the program was promoted with marketing collateral.

San Benito County's goal was to establish a quality grant program that aligned with our strategic goals: (1) operational development & excellence, (2) planning for sustainable growth, (3) technology, (4) community engagement, and (5) health & Safe communities, while prioritizing micro-businesses that have faced historical barriers to accessing capital. On January 25, 2022, the Board of Supervisors authorized the County Administrative Officer and staff to take all necessary steps to implement and accept the California Microbusiness COVID-19 Relief Grant to administer grants to qualified microbusinesses. On February 8, 2022, the Board of Supervisors approved and delegated the California Microbusiness Grant Oversight to the Economic Development Committee, consisting of two Board Supervisors and Administrative staff. During this meeting, it was also publicly announced that the County would be working towards finalizing the program and prepping for acceptance of grant applications. On February 10, 2022, the Economic Development Committee established a collaborative working group of partner agencies with connections to community businesses to support the California Microbusiness COVID-19 Relief Grant.

Given the county demographics¹, with 87.4% identifying white alone and 60.8% identifying as Hispanic or Latino, San Benito County offered materials in English and Spanish and provided directions on how to access other languages if necessary. Throughout the duration of the program, they conducted three rounds, of which they successfully awarded eleven (11) microbusinesses out of the total forty-eight (48) applications received.

One of the challenges the County encountered throughout this process was the need for more eligible applicants to apply to the program based on the criteria—the established standard limited the participation of local businesses. As the County may not modify the requirements, the selected group implemented a strategy to increase communications. San Benito County contacted even more community groups to address this matter, including the Hollister Downtown Association and the Community Service & Workforce Development office.

San Bernardino County Economic Development Department can report that the Microbusiness COVID-19 Relief Grant touched a large majority of businesses. Outreach engagement during May and June included phoning applicants, promoting the grant to schools and organizations, and cold-calling potentially qualifying businesses. Weekly the grant operations team met to determine potential outcomes of the grassroots efforts set forth by the collective team. The County has reached out to local cities and community-based organizations to continue to get the word out about the grant and its availability.

Throughout May and June, the County continued to contact incomplete applicants and offer one on one assistance from the team. The County reached out to the Inland Counties Legal Services and they promoted the program to their clients, as much of their clientele fit the program criteria. The team also got in touch with local colleges and universities to promote the grant to student entrepreneurs. These schools included Cal State University San Bernardino, Barstow Community College, Chaffey College, and San Bernardino Valley College. Flyers were sent out in both English and Spanish.

The County compiled a list through D&B Hoovers of potential businesses who may qualify for the grant. The team reached out to these businesses through cold-calling and emailing, to notify them of the grant. Assistance was provided to those who were interested.

San Bernardino County Economic Development Department has made a great effort in contacting applicants directly through making calls to those who had begun the application but had not yet submitted. As of May 11th, the office completed the call list. Over 1059 calls have been made with 394 calls having been answered by applicants. Out of the applicants who answered the phone, 252 people were given further assistance by our staff. The County believes that through completing this call list, they were able to encourage more applicants to complete their applications through providing them one-on-one support.

Overall, the County issued a total of 1,501 Microbusiness Grants for the entire program. By advertising through social media, television, and print the County was able to reach a large target audience and obtain over 4,000 applications. To reach a diverse population, the County created a grant website which offered information about the program in English, Arabic, Chinese, Korean, Persian, Somali, Spanish, Tagalog and Vietnamese.

The County also utilized the services of four outreach partners to aid applicants, via the phone, email, or in-person regarding any questions or help submitting/resubmitting the required documentation. During the duration of the program these outreach providers also performed outreach activities by working closely with local community-based organizations, Chambers of Commerce, and business service organizations to spread the word and conducted door-to-door marketing in targeted areas.

The primary challenges we experienced during the program were:

- Unqualified/out of region applications.
- Applicants failing to submit complete and accurate documentation, which resulted in additional questions or applicants being excluded from funding.
- Applicants failing to adhere to deadlines.
- Business owners that applied under their business names but did not have an actual bank account under that name, which resulted in warrants being returned to the County to have the applicants name added to the warrant.

The activities during this round consisted of:

- Assisting applicants with completing required document submission.
- Review and processing of the remaining eligible applications.
- Answering questions.
- Issuance of remaining grant payments

Mission Economic Development Agency (MEDA) started receiving applications for the program on August 8, 2022, and opened the application period multiple times. At the end of last year (2022) MEDA used a different strategy to process applications via direct referrals only. Similarly, they focused their outreach to specific businesses that they (and their partners) believe may qualify for the program, although they did not receive many referrals from their partners for the past few months. Outreach continued to be focused on businesses in the City of San Francisco, through other MEDA Programs, past clients, knocking on doors, and partner organizations. MEDA's FinTax program became a referral source for our grants, since it was easy for the team to collect documentation.

All of the marketing efforts and different initiatives have resulted in 830+ profiles created in the application management platform Lenderfit, with 391 applications received (including applications from businesses not in San Francisco, and not including duplicate applications), and 80 disbursed grants. The main reasons for declining applications continue to be 1) businesses not providing full documentation to package the application, 2) businesses receiving the CA Relief Grant, and 3) businesses with revenues over \$50,000 in 2019. This was a very difficult program to implement because many of the businesses in the network and partners' networks were not eligible for the reasons above.

Solano County partnered with the Workforce Development Board of Solano County (WDB) and the Solano-Napa Small Business Development Center (SBDC) to administer the MBCRG in Solano County.

Due to the outreach efforts and grant partnerships conducted, 1002 applications were received in English and Spanish. Over half of the applicants were minority business owners and more than 619 were female business owners. Over 503 applicants identified as Black/African American and nearly 167 were Hispanic/Latino.

WDB staff have been providing technical assistance to applicants on providing documentation needed for verification purposes. Technical assistance has included understanding the tax documents needed to show eligibility. If tax documents were not available, staff have provided technical assistance on alternative means of showing the business is a qualified microbusiness.

The WDB has completed 179 verifications and approval of applications for contracts. 179 have completed the contract process and have been fully awarded their funds. Unfortunately, 261 businesses who was notified of their award was non-responsive, despite several attempts to connect with them. The WDB also identified several fraudulent applications, with 30 + applicants located out-of-state. Additional businesses did not meet the criteria of a qualified microbusiness per the grant requirements.

During this last reporting period, WDB scrubbed the new applications submitted to identify the next round of approved applicants.

In April WDB received 67 approved applications to start the vetting process. WDB staff continued vetting applicants on a first come first basis until the grant deadline was reached.

In June 2023, WDB ended the grant by vetting and approving a total of 179 grants.

Rural Innovations in Social Economics distributed flyers through the Esparto Chamber of Commerce, handed out flyers at their front desk in Esparto, and distributed program information in the Fall and Winter editions of 'Valley Voice'. The Yolo County Farm Bureau has distributed flyers and program information in their December, and January newsletters and in their regular email distributions. Children's Home Society has supported distribution to childcare providers across Yolo County via email blasts and mailing flyers to childcare providers in the County. In addition to community outreach in hard-to-reach communities in West Sacramento, Yolo County Children's Alliance has assisted with the development of outreach materials in Russian. Additionally, outreach was conducted to Yolo Farm Bureau at their December 3rd meeting, encouraging referrals to farmers, which led to an increase in applications from farmers.

Yolo County staff have fielded calls and emails from interested microbusinesses to assist them in applying and navigating the program's eligibility requirements. Staff has also assisted applicants in turning in attachments as part of their application when technical difficulties are presented. Additionally, the staff has continued maintaining the webpage to host all program information in one place, including applications in English, Spanish, and Russian.
