加州非营利表演艺术资助计划的目的是向符合该计划规定条件的非营利表演艺术组织提供资助，以促进劳动力发展。

该计划的资助方式是：根据申请人在 2019 纳税年度的年度总收入，按照先到先得的原则发放指定金额。

本部分下的资助金额只能用于以下用途：

3. 招聘、培训、发展等人力资源相关费用；和/或
4. 其他运营费用或员工设备。
