1. The VIOLENT CRIME RATE is the sum of all murder, forcible rape, robbery, and aggravated assaults reported to the police.
2. The PROPERTY CRIME RATE is the sum of all burglary, larceny-theft, and motor vehicle theft reported to the police.
3. The INDEX CRIME RATE is the sum of the following: (murder, rape, robbery, agg. assault, burglary, larceny and motor vehicle theft)
which serves as an indicator of the jurisdictions crime experience.
4. The FBI ended UCR (Uniform Crime Report) data collection in 2020. 2021 data was reported under the new standard- NIBRS (National Incident Based Reporting System.)
5. NIBRS collects injury type and weapon data, for assaults, that was not collected in UCR.
6. Classification of Aggravaed Assault is different in NIBRS, than it was in UCR.
7. Under UCR- Offenses were classified as Aggravated Assault if they involve the use of a firearm, knife or cutting instrument, or other dangerous weapon,
and the victim sustained serious aggravated injuries; offenses that did not meet this standard were required to be reported as other assaults—simple, not aggravated.
8. Under NIBRS- Offenses are classified as Aggravated Assault when one of two things is present in the incident: 1) a weapon was used (including displaying a weapon
in a threatening manner) and/or 2) the victim must have sustained serious injury which required medical attention (even if the victim refused the medical attention).
