RE: Reciprocity Process

Current criteria for individuals seeking direct reciprocity for IFSAC accredited certifications has been allowed for candidates who can show proof of testing and have received the certification within 2 NFPA cycles of the most current DFPC certification cycle. On April 30, 2016, IFSAC adopted the following language into their by-laws:

12.7.1.1 No entity shall issue an IFSAC seal and number for any level for which the individual has not successfully completed a level appropriate examination administered by the issuing entity. 12.7.1.1.1 Entities shall have written policy that requires examination for all certificates and seals issued by the entity.

As of July 1, 2016, the CDFPC Policy and Procedure Manual will reflect this change as shown below:

- 7.9.1: Applicants possessing a valid IFSAC or Pro Board Fire Service Professional Qualifications System (Pro Board) accredited certification shall be granted a "Letter of Recognition" by CDFPC after fulfilling the following requirements:
 - 7.9.2.1: The applicant must be a current resident of Colorado (proof of Colorado Driver's license) or affiliated with a Colorado Emergency Services Agency.
 - 7.9.2.2: Pay a non-refundable processing fee for level(s) of recognition desired.
 - 7.9.2.3: Possess a valid accredited certificate from IFSAC or Pro Board by providing a copy of the eligible certificate with IFSAC or Pro Board seal.
 - 7.9.2.4: Provide proof of certification that must be accredited under the current or previous edition of the applicable standard. The date that the certification was issued cannot exceed 2 NFPA cycles from date of issue.
 - 7.9.2.5: The applicant's certification must have been received through a testing process and not a grandfathering or historical recognition process.
 - 7.9.2.6: An applicant that is issued a "Letter of Recognition" will allow the applicant to test into the State of Colorado certification system at his/her current level or next highest level.
 - 7.9.2.7.1: This "Letter of Recognition" is valid for two years from the time of issue.
 - 7.9.2.7.2: Once candidate has begun certification testing process, their certification testing must be completed within one year.
 - 7.9.2.7: The applicant meets all requirements set forth by the State of Colorado certification policies and procedures.
 - 7.9.2.9: The applicant must pass both the written and psychomotor examinations, when required for the certification level they are requesting. The examinations must be administered by a Colorado State certified proctor.
 - 7.9.2.9.1: For firefighter I, II and Fire Officer I Levels, the applicant must also successfully complete a live burn practical examination that must be administered by a Colorado State certified proctor.
