**CONSENT TO PROCEED ON CONDITIONAL GUILTY PLEA

**WAIVER OF RIGHTS RELATING TO ENTRY OF NOT GUILTY/GUILTY PLEA HEARING  
CONDUCTED BY VIDEO/TELEPHONIC CONFERENCE**

The defendant understands that, under Rules 10 and 11 of the Federal Rules of Criminal Procedure, he/she has the right to be personally present at the hearing at which the defendant enters a not guilty or guilty plea. Defendant also understands that, ordinarily, defendant has the right to have his/her attorney physically present with the defendant during that hearing and that, if he/she requires the assistance of an interpreter, the interpreter would also be physically present with the defendant during that hearing.
