## Rate Change: Five Drugs in the Medical Injectable and Site of Care Home Infusion Therapy (HIT) Programs

Highmark is changing the reimbursement rates for five drugs, which are part of our Medical Injectable Drug and Site of Care Home Infusion Therapy (HIT) programs.\* These changes are being made to align with Highmark's standard average selling price (ASP) strategy.

The chart below outlines important information regarding the five drugs affected by this reimbursement change. Please use [Availity](#)<sup>®</sup> to access the proposed rate on the effective date, which is different than Highmark standard, for each drug listed below:
