#### 1. Introduction

This survey aims to establish the report on 'Local and regional authorities in the governance of the energy union' commissioned by the European Committee of the Regions (CoR) Directorate for Legislative Work I — Unit B2 (ENVE commission) in collaboration with the the Council of European Municipalities and Regions (CEMR).
