Electrical and electronic equipment (EEE) and batteries contain materials, components, and substances that may be hazardous and present a risk to human health and the environment if not handled correctly. If you are an EU customer, you play an important role in recycling your waste electrical and electronic equipment (WEEE) when you take it out of service.

IDENTIFYING EQUIPMENT

Equipment marked with the WEEE label (below) is EEE. The symbol indicates that the product should not be discarded as unsorted waste but must be sent to separate collection facilities for recovery and recycling.
