# **Delaware Tribe Regains Federal Recognition**

Chief Jerry Douglas proudly announces, "Delaware Federal



Recognition
is restored."
On Tuesday,
August 11, 2009
the Delaware
Tribe of Indians
was published
in the Federal
Register list
of Federally

Recognized Tribes, once again restoring our rights as a federally recognized Indian tribe. This action came as a result of the Secretarial election held on Tuesday, May 26, 2009 in which our tribal members overwhelmingly voted to ratify the

Tribe's 1982 constitution as amended through November 1, 2008, subject to the October 24, 2008 Memorandum of Agreement between the Delaware Tribe and the Cherokee Nation. The election was conducted by the Bureau of Indian Affairs for the Tribe in accordance with Part 81 of Title 25 of the Code of Federal Regulations. A memo from the Dept. of Interior received by the tribe on July 28, 2009 stated the election was carried out properly and the tribe's constitution was accepted by the Dept. of Interior, the memo further stated that the tribe will be included on the next list of recognized tribal entities. 

# Oklahoma Tribes Approved To Issue \$90 Million In Bonds

September 15, 2009 -- The Internal Revenue Service (IRS) has approved the plans of four Oklahoma Tribes to issue \$22.5 million apiece in tax-exempt bonds for economic development and infrastructure projects.

The projects proposed for the bond issues include projects for the Kaw Nation, the Ponca Tribe of Oklahoma, the Delaware Tribe of Indians and the Fort Sill Apache Tribe.

Earlier this year, as part of the American Recovery and Reinvestment Act of 2009 (ARRA), the IRS established a new tax-exempt Tribal Economic Development Bond (TEDB). The IRS set a \$2 billion cap on the total amount of amount of TEDBs that could be issued nationwide.

The maximum possible bond allocation a Tribe could receive was \$30 million.

"We are extremely excited," says Kaw Nation Chairman Guy Munroe. "We have had this project in mind for a long time. When completed,

Tribal members are encouraged to have a correct address with the Election committee as ballots will be mailed to all voting age tribal members Monday, October 5, 2009.


A polling place will be available for those wishing to place their ballots



well and my prayers are with those families who have loved ones serving in the military. As you know from the recent tribal mailing our FEDERAL RECOGNITION HAS BEEN RESTORED. This is the long awaited and exciting news we've been waiting for. I wish to express my THANKS to all who worked tirelessly to make this happen and to those tribal members who participated in the Secretarial Election. The Chief, Tribal Council, Trust Board, Attorneys and staff worked hard to get this accomplished. Now we must begin the journey to reestablish the many programs lost and apply for new and better services for our tribal members. ### From the Desk of Thomas J. Peckham, Attorney

Congratulations! I am ecstatic that the Tribe's separate federal recognition was restored through the Oklahoma Indian Welfare Election held on May 26. The day after, the overwhelming results of that election were certified by the BIA Regional Director, which lawfully restored the Tribe's recognition independent of the Cherokee Nation. May 27, 2009 is your independence day, at least with respect to the government-to-government relationship with the United States. It was a long four-and-a-half years, but it is over.

With the publication of the Tribe's name on the List of Indian Entities Recognized and Eligible to Receive Services from the United States on August 11, the last formal step was completed. I believe the Tribe will never have to confront this issue again and that the roller coaster ride of the last century is history. Because of a 1990s law, the BIA cannot do what it did to the Tribe in 1979. While separate recognition came with a cost--the Memorandum of Agreement with the Cherokee Nation--I am confident that the Tribe will find ways to prosper both governmentally and economically.

Much remains to be done to build that future, and your current and future tribal leaders will need your your support, and your patience, as they turn to the task of rebuilding the Tribe's infrastructure and planning for the future. But for today, take a moment to celebrate the Tribe's restoration. It seemed like a long time, but compared to the even longer road

Next Steps

With the restoration issue finally behind the Tribe, several other issues that I have written about over the past years await final resolution.

We will move forward with the settlement in the breach of trust case filed in the Court of Federal Claims ("CFC Action") in 2002. Resolution of that case became intertwined with the recognition issue because of the prospect of using the same piece of legislation to address both. That is no longer necessary.

#### **Tribal Trust Funds**

When we ran into obstacles in the Senate with the restoration legislation and Interior saw the need to shift the recognition issues to the Oklahoma Indian Welfare Act, it became apparent that it might be possible to receive some of the funds to which the Tribe's government is entitled under 25 U.S.C. § 164 more quickly through an administrative request. Under that statute, those funds come directly to the Tribe for tribal purposes. Those funds have not yet been released, and legislation might actually occur first, but much progress has been made.

Other funds to which the Tribe is entitled are embedded in the legislation that we will try to have passed by the end of the year. Congressman Sullivan remains very supportive of the Tribe, and there is hope that we will be able to move the legislation quickly (now that restoration of recognition is no longer a part of it). The total to which the Tribe is entitled is roughly \$1.4 million.

#### Per Capita Funds

Some of the money related to the CFC Action and the 1980 Delaware Judgment Funds Act will be (or has been) distributed directly to Tribal members as per capita payments. Please read the following very carefully to see if you are entitled to a payment and when you can reasonably expect that you might receive a payment.

First, only Tribal members who were enrolled in the Tribe as of August 1, 1980 <u>and</u> on the roll of Tribal members prepared by the Department

of the Interior pursuant to the 1980 Act will receive payments. If you were not enrolled on that date, you will not receive any payments.

Second, it is important to realize that there are two sources of payments, totaling roughly \$1.9 million.

The first source of per capita payments is related to a case filed in a federal court in Idaho in the 1980s that lay dormant for more than two decades until it was rediscovered in relation to the CFC Action. (The Tribe and its members are not parties, so we had no practical way to know about it.) It involves only Tribal members born on or after October 4, 1972 and on or before August 1, 1980 and who were on the 1980 Act roll. Many of those members have already received checks. We are also in the process of preparing another list of names and addresses for the court. (If you have contacted the Tribe or me since July 2008, your name and updated address will be included on that list.) If you meet the criteria mentioned above (born between those dates and on the 1980 roll) and you have not received a check or contacted the Tribe recently, please send vour current information to the Tribe at dtriberegistration@yahoo.com or write 170 NE Barbara, Bartlesville, OK 74006. These payments are in the \$900 range and account for about \$1.2 million of the \$1.9 million in total per capita payments.


The second source of per capita payments is tied into resolution of the CFC Action. At some point in the future (but not now) the roughly 9.000 Tribal members on the 1980 roll should receive per capita payments of roughly \$85. But there are several steps that must occur first. One, either legislation must be passed by Congress or a separate settlement agreement through the Court must be put into place by a court order. (For reasons too complicated to address here, Congress may well be the faster approach.) Two, the 1980 Act roll must be updated with current addresses for as many of those 9,000 Tribal members as possible. Third, unless the settlement is part of legislation, federal law will likely require that the Tribe go through a lengthy process to establish a "use or distribution plan." That can take a year or more. In short, it could still be one or more years before any of the "second group" checks go out.

Please, keep your address current with the Tribe. It not only will make any per capita distribution easier when it is time, but it also is the only way to receive this newspaper and to make sure you are aware of Tribal activities, including elections.

Again, congratulations on the restoration of your separate Tribal recognition. It is an honor to work with the Tribe. You have a long and proud history in the face of tremendous adversity. Over the past years, I have seen the commitment and perseverance of your Tribal leaders and of many Tribal members. You have much to be proud of. Celebrate and honor your past and your future.

### **Canidates for Trust Board Members**



#### Chester "Chet" Brooks, Jr.

Delaware Friends and Relatives: OUR FEDERAL RECOGNITION HAS BEEN RESTORED UNDER THE **OKLAHOMA INDIAN** WELFARE ACT, just like our Chief, myself and most other Council and Trust Board Members said it would be, almost a vear ago in last vears election. All of our Tribal Leaders, both past and present, who have struggled with this problem for Thirty (30) years SHOULD BE HONORED. I personally saw this hiatus coming in the early 1970's upon first reading Weslager's book, "The Delaware Indians - A History." My thought then was that there was no way our people ever would have done what Weslager described in his closing chapters. About 10 years later - 1982 - after reading some of Richard C. Adams works I knew that our side of the picture was very different than some historians or court actions reported - this was 3 years after the BIA's illicit action of leaving us off the first ever published list of Federally Recognized Tribes in 1979.

Do you know that in 1988 I became convinced it was the fraud of our Kansas Agent, John G. Pratt, that had done our Tribe in during both 1866 and our so called April 8, 1867 Agreement. It was evident after personally traveling to Washington, DC, visiting the Bureau of Archives and obtaining microfilm copies of my Third Great Grandfather John Anderson Sarcoxie's and Capt. Falleaf's protest letters.

Do you know that in 1991 I personally traveled to the NCAI (National Congress of American

Indians) meeting in San Francisco at my own personal expense - our tribe then lacked the funds to send any Elected Officials. At the said NCAI meeting I was introduced to a Menominee Indian woman who was running for Congress in Wisconsin, Ada Deer. She wondered why an Oklahoma Indian would make a small political contribution to her political campaign in Wisconsin. I truthfully answered because I know you played a large part in your own Tribes restoration and if you are elected perhaps you can help my tribe in its restoration. She did not win her seat in Congress but little did I know then she would be appointed Assistant Secretary of Interior - BIA. She certainly did help.

Do you know that in 1994 I was the campaign stalwart and largest contributor to Lenape Candidates for Tribal Independence? We won 3 of 4 seats and within the week me and my third Son Ian were in Denver, Colorado, again at my own expense, trying to help get a resolution supporting our Tribal Recognition at NCAI. We were successful that year. Our Tribal Delegation had not been successful in that same regard the prior year.

Do you know that in 1995 I was in Washington, DC, again at my own expense, carrying a sign in an HONOR OUR TREATIES PARADE? The sign said, "FEDERAL RECOGNITION IS NOT A LIST - TWENTY - TWO TREATIES PROVE MY TRIBE EXISTS" Ada Deer, then Assistant Secretary of Interior - BIA and a Solicitor caught me on the Capital steps and wanted their picture taken beside me holding up the sign. A year later, after she had reinstated our recognition retroactive to 1979, she sent me a personal letter thanking me for my stalwart support in achieving our recognition. IMHO, it is her I and Mv Tribe should THANK. THANK YOU ADA DEER, I know you are proud of our recovery and restoration to federal recognition under OIWA. Thanks are also due to my oldest Son and third Son who are Trust Board candidates in this election. They both worked many years in several smoke shops, keeping them going while the above was accomplished. I have almost run my limit on space so I will let my two sons

continue our family history, where our Tribe has been and where we are going.

When elected I promise to uphold the Constitution and Trust Document and member rights nationwide, so long as the Great Spirit allows me to continue my walk on good green Mother Earth. Wanishi, Chet Brooks.



#### Ian Nathaniel Brooks

To All My Lenape - Delaware Relatives:

My Brother has given you the first 6 generations. The 7th generation was our 4th Great Grandfather John Anderson Sarcoxie (Lenape for Tall), born in 1784 on the Upper Sandusky River-Ohio Country. His Father was Kick-Tha-We-Nund, aka William Anderson. He was born c. 1750 at Beaver Creek (20 - 30 miles West of Ft. Pitt). His Mother was Daughter to John Killbuck, our 7th GGF. He marked that first U.S. Treaty in 1778 along with Capt. Pipe and White Eyes. Our 8th GGF was Netawatwes aka Newcomer. Netawatwes retired to the spirit world on Oct. 31, 1776 while at the second U.S. verbal treaty meetingwhere the revolutionaries asked us to convince as many tribes as possible to remain neutral in the revolution. There would never have been a U.S. if we had not done so. Netawatwes Mother (our 9th GGM) was the Daughter of Tammanend or Tammany that made a Treaty with William Penn in1683. Many years latter, the men of George Washington's Army dubbed Tammany "Americas Patron Saint," as they celebrated survival of their hungry winter at Valley Forge on Mayday, aka "St. Tammany Day." Relatives -Twelve generations back to the Lenape Indian Tammany. All Delaware's have similar genealogy. A "SAINT'S"

Grandchildren have the privilege to be LENAPE and obligation to continue support of our Tribe, as our ancestors did


I was born January 23, 1981 at the Claremore, OK Indian Hospital. My Dad entered the Indian Tobacco business when I was less than 3 years old and I have been involved with our Tribe all of my almost 29 years. My Dad and older Brother were very busy founding and managing nine Indian Smoke Shops and doing the things for our Tribe that my dad describes well and truthfully in his BIO. Because of these reasons my younger Brother Lee and Sister Chimalus and myself were home schooled until I was 13 years old. Lee and myself then went to the Elliot Academy for further education and my only Sister Chimalus decided she wanted to attend High School and started public schooling in 9th grade, graduated from Charles Page High School, Sand Springs, OK and is now in her third year at University of Oklahoma studying foreign languages. Her higher education was possible, because of a Gates Millennium Scholarship, which she could qualify for, only if she had a CDIB Card showing the blood of a "Federally Recognized Tribe." In 1999, I became the Owner of the only Indian Smoke Shop, Oklahoma City - City limits. Of nine smoke shops our family started, it was the only one that did not make substantial money. In fact, we still owe a relative a substantial sum of money he loaned me, guaranteed by my dad. I have personally experienced both the 8 successes and 1 failure in the Indian Tobacco Business. Because of this, I know our Tribe must preserve and grow our Trust Funds. I also know our Tribes hope for our future rest in economic development and the willingness and effort of our youth to advance. I agree with my Dad when he says "SUCCESS IS JUST A MEASURE OF HOW FAR WE BOUNCE, AFTER WE HIT BOTTOM." As a Tribe, we have recently been bottom, since before my birth, when we lost our Fed. Recognition in 1979. As youthful candidates for the Office of Trust Board

Lenape Brothers, Sisters and All of my Delaware Relatives:

I am a candidate for Trust Board for reasons to be explained shortly. My Brother and I are the 10th Great Grandsons of and the twelfth Generation following the Great Lenape Chief Tammany, who marked the Treaty - Land Deed with William Penn in 1683. Our Father is Chester (Chet) Brooks, A/K/A "Achi."- A Lenape nickname. We are the Grandsons of the late Helen Louise (Camp) Brooks. Our Great Grandmother was Mary Sarcoxie, Dawes Roll #31323. Our 2<sup>nd</sup> Great Grandfather was Little John Sarcoxie, Roll #119D (the D means he was a registered Delaware that had come here from Kansas and that he was still living when Dawes Roll was taken). Our 3<sup>rd</sup> Great Grandfather was Ta-mun-do-a-wa (killed on a buffalo hunt when Little John was a small boy so Little John was raised by his Grandfather). That's six generations back and I will let my brother pick it up with the six generations that preceded them.

I was born in Yreka, Calif. 1963 - my dad was a forestry student and working for the US Forest Service. We then lived in Eureka, Calif. For

6 months where my dad attended Humboldt State University. The next three years were spent in Stillwater. OK while my dad finished his degree. After that, we moved to Ok. City for 2 years and Greensboro, NC for 2 years while my dad worked for Southern Pine Association. We then moved to Shreveport, LA for 4-1/2 years where my Dad was top-salesman for a large wood preserving Corp. While there my Dad bought a sailboat when he received his \$1,300 + "Delaware Indian Money." He was also a leader in our Cub Scout Pack. We then moved to Washington, DC for 2 years where my Dad was Exec. Vice President of a Wood Treating Association. While in DC. I really enjoyed several trips to the Smithsonian Museum and sailing on the Potomac River. I know my Father developed his ability to find old documents at the Bureau of Archives while there. As I write this campaign bio my Dad is preparing to travel to Delaware Water Gap, PA to respectfully help rebury the remains of 101 of our Lenape Ancestors again he is traveling on his own very limited money but this time it will be reimbursed by a Smithsonian Grant within a couple of weeks. In 1976, we moved to Tulsa and my dad became a Lumber Broker. The Lumber business was not very good monetarily to our family but while my Dad struggled to make a living, I attended East Central High School.

In 1984, My Uncle Larry Joe Brooks and my Dad started the first Native American Tobacco Store within the City Limits of Tulsa, OK. My Uncle had been the Manager at the first & 2nd Indian Smoke Shops in Oklahoma starting in 1978. The State of Oklahoma filed criminal charges against my Uncle and Dad after they had been open less than three weeks. My relatives went to Tulsa County State Criminal Court and the Court correctly found them "NOT GUILTY." The State of Okla. Appealed these charges through the State Court of Criminal Appeals, The Federal 10<sup>th</sup> Circuit Ct. of Appeals and finally to the U.S. Supreme Court where we won. I say, "WE WON" because I went to work at that first Tulsa Smoke Shop

in 1985 and spent over 11 years as the Manager at one Smoke Shop while my Dad did the things for our Tribe he describes in his article in this issue of DIN. Actually, it was all 39 of the Tribes in Oklahoma who won because of this type of Court action. Since I am out of space, I will let my Brother Ian conclude.

When elected to the Trust Board I promise to uphold the Delaware Constitution & to protect the rights of Tribal Members, nationwide. I respectfully ask your votes for my Father, my Brother and myself. Wanishita Robert E. (Reb) Brooks.

Like my grandfather Anderson Wilson and my Uncle Isaac "Ike" Secondine before me, both who went to Washington D.C. in the 1920's to fight for our treaty rights regarding the Kansas Reservation Land Payment, I too am devoted to the preservation of our tribal culture and traditions. I am an active member of the Lenape Gourd society and Lenape Veterans colorgaurd. Currently, I serve the Sac and Fox Nation as its Tribal Administrator and oversee approximately 250 employees and all federal and tribal programs.

I have also had the pleasure and the honor to serve our people for two years as an Associate Judge on the Delaware Tribal Court. During this time I learned many things and I want to continue serving our people.

With the current federal restoration of our tribe, now is not the time for stagnation, but rather it is a time for new creative thought, which will help us move forward. Now is a time to listen to our elders, listen to our people, and listen to our children; knowing that we are working for the preservation of our culture and our heritage, and following the path of our ancestors as strong and proud Lenape people.

the project will benefit Kay County surrounding communities."

The bond applications were prepared and submitted with the help of attorneys Ken Bellmard and Valerie Devol from Rubenstein McCormick and Pitts in Edmond, Oklahoma.

"Tribes have long needed easier access to the capital markets to finance economic development and infrastructure projects," Bellmard says. "Our hope is that this stimulus program will help demonstrate investments in Tribal projects are safe and profitable."

Devol agrees. "Many people have been hesitant invest in Tribal projects in the past without realizing the tremendous opportunities and advantages Tribes have to offer. Through this bond program, we can now promote these benefits to a wider audience."

Spud was born May 12, 1921, in Copan, Oklahoma the son of Wesley and Pearl (Wilson) Burrows.


Spud was always proud of his Delaware Indian heritage on his mothers' side and his membership in the Delaware Tribe of Oklahoma.






