Special Inspections Required and Special Inspector Designation

8 CCR 1507-30 and IBC 107.1 require that a Statement of Special Inspections be completed by the *registered design professional*, when required.

PRIOR TO THE COMMENCEMENT OF CONSTRUCTION

On projects requiring special inspections, the *registered design professional in responsible charge* shall prepare a Statement of Special Inspections in accordance with IBC Chapter 17.

DFPC will not issue a permit when Special Inspections are required, unless the Special Inspector has been designated and qualifications provided to DFPC prior to the commencement of construction.
