COMMENT SOUGHT ON HAWAIIAN TELCOM, INC.'S PETITION FOR WAIVER OF HIGH-COST UNIVERSAL SERVICE SUPPORT RULES

The Wireline Competition Bureau seeks comment on a petition filed by Hawaiian Telcom, Inc. (Hawaiian Telcom) on December 31, 2007, seeking waiver of the Commission's rules regarding high-cost universal service support. Specifically, Hawaiian Telcom seeks a five-year waiver of section 54.309 of the Commission's rules to allow it to receive high-cost model support by averaging its line costs on a wire center-by-wire center basis, instead of on a statewide basis. Hawaiian Telecom also requests a one-time waiver of section 54.314(d)(vi) of the Commission's rules to allow Hawaiian Telcom to receive high-cost model support immediately upon grant of its petition. Hawaiian Telcom estimates that grant of its waiver request would allow it to receive approximately \$6 million per year in high-cost model support.

Interested parties may file **comments on or before February 19, 2008** and **reply comments on or before March 5, 2008**. All pleadings are to reference **WC Docket No. 08-4**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.⁵
