WIRELINE COMPETITION BUREAU SEEKS COMMENT ON THE JOINT PETITION OF UPPER PENINSULA TELEPHONE COMPANY AND MICHIGAN CENTRAL BROADBAND COMPANY, LLC TO WAIVE THE STUDY AREA BOUNDARY FREEZE

On December 29, 2010, Upper Peninsula Telephone Company (Upper Peninsula) and Michigan Central Broadband Company, LLC (Michigan Central) filed a joint petition for waiver of the study area boundary freeze codified in part 36 of the Commission's rules.¹ The Commission froze all study area boundaries effective November 15, 1984 to prevent incumbent Local Exchange Carriers (LECs) from establishing separate study areas made up only of high-cost exchanges to maximize their receipt of high-cost universal service support.² A carrier must therefore apply to the Commission for a waiver of the study area boundary freeze if it wishes to transfer or acquire additional exchanges. Upper Peninsula and Michigan Central seek a waiver of the study area boundary freeze to divide Upper Peninsula's existing 19-exchange Michigan study area into a 15-exchange study area that will continue to be operated by Upper Peninsula, and a 4-exchange study area that will be operated by Michigan Central.³

Interested parties may file **comments on or before February 11, 2011** and **reply comments on or before February 28, 2011**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.⁴
