WIRELINE COMPETITION BUREAU ANNOUNCES THE OFFICE OF MANAGEMENT AND BUDGET'S APPROVAL OF THE COMMISSION'S REVISED ANNUAL REPORT COLLECTION FOR INMATE CALLING SERVICES PROVIDERS

WC Docket No. 12-375

By this Public Notice, the Wireline Competition Bureau (WCB) announces that the Office of Management and Budget (OMB) has approved the Commission's revised Annual Report Data Collection related to calling services for incarcerated people. Inmate calling services (ICS) providers' next Annual Reports and Certifications will be due April 3, 2023.

In the 2015 ICS Order,³ the Commission required that all ICS providers file Annual Reports providing data and other information on their ICS operations, as well as annual certifications that the reported data are complete and accurate and comply with the Commission's rules. Pursuant to the authority delegated to it by the Commission in the 2015 ICS Order,⁴ WCB created a standardized reporting template (FCC Form No. 2301(a)) and a related certification of accuracy (FCC Form No. 2301(b)), as well as instructions to guide ICS providers through the reporting process.

In the 2021 ICS Order,⁵ the Commission revised its ICS rules, which necessitated changes to the Annual Reports. On December 21, 2021, WCB issued a Public Notice seeking comment on its proposed revisions to the instructions and annual reporting and certification templates for the Annual Reports.⁶ After considering the comments and replies submitted in response to the Public Notice, WCB released the Annual Report Adoption Order on June 24, 2022, revising the instructions, the reporting template, and the
