## WIRELINE COMPETITION BUREAU ANNOUNCES CERTAIN RDOF CENSUS BLOCK GROUPS ARE ELIGIBLE FOR OTHER FUNDING PROGRAMS

**AU Docket No. 20-34**  
**WC Docket No. 19-126**  
**WC Docket No. 10-90**

By this Public Notice, the Wireline Competition Bureau (WCB) announces that certain Rural Digital Opportunity Fund (RDOF) census block groups (CBG) are now eligible for other funding programs. Specifically, Charter Fiberlink – Michigan, LLC (Charter Fiberlink Michigan) (Study Area Code (SAC) 319053), Charter Fiberlink – Missouri, LLC (Charter Fiberlink Missouri) (SAC 429051), Charter Fiberlink OR-CCVII, LLC (Charter Fiberlink OR) (SAC 539021) and Charter Fiberlink CCO, LLC (Charter Fiberlink CCO) (SAC 339064) (collectively Charter) have notified the Commission that they will not fulfill their commitment to offer voice and broadband service to certain additional CBGs within their RDOF supported service areas in Michigan, Missouri, Oregon, and Wisconsin.<sup>1</sup> Co-Mo Comm, Inc. d/b/a Co-Mo Connect (Co-Mo Connect) (SAC 429038) has also notified the Commission that it will not fulfill its commitment to offer voice and broadband service to certain CBGs within its

On May 10, 2024, the Bureau announced that Charter had defaulted on the eligible census blocks within CBGs covering 1,675 locations in Michigan, 10,438 locations in Missouri, and 11,322 locations in Wisconsin. *Wireline Competition Bureau Announces Certain RDOF Census Block Groups are Eligible for Other Funding Programs*, AU Docket No. 20-34 et al., Public Notice, DA 24-449 (WCB May 10, 2024) (*Charter Post-Authorization Default Public Notice*). With this additional notification, Charter Fiberlink Michigan is defaulting on 2,253 additional locations in Michigan, Charter Fiberlink Missouri is defaulting on 5,115 additional locations in Missouri, Charter Fiberlink OR is defaulting on 820 locations in Oregon, and Charter Fiberlink CCO is defaulting on 3,661 additional locations in Wisconsin. Charter remains obligated to deploying service to the remaining CBGs in its RDOF auction supported areas.

RDOF-supported service area in Missouri.<sup>2</sup> Additionally, Coleman County Telephone Cooperative, Inc. (CCTC) (SAC 442057) has notified the Commission of its decision to withdraw from the RDOF support program in all the CBGs covered by its authorized winning bids in Texas.<sup>3</sup> The carriers will be subject to penalties, as described below, for their defaults. Finally, we grant Charter’s request that we revise the public notice we released on May 10, 2024 to reauthorize Charter in 16 CBGs it “inadvertently included” in a previous default.<sup>4</sup> Accordingly, the eligible census blocks within these CBGs will be added back to Charter’s service area and Charter will again have an enforceable commitment to serve the census blocks with voice and broadband service pursuant to its RDOF obligations.

By announcing that 1) Charter will not serve the identified eligible census blocks within the defaulted CBGs in Michigan, Missouri, Oregon, and Wisconsin, 2) Co-Mo Connect will not serve the identified eligible census blocks within the defaulted CBGs in Missouri, and 3) CCTC is defaulting on the eligible census blocks within the CBGs covered by all its authorized winning bids in Texas,<sup>5</sup> we notify stakeholders that the relevant census blocks are eligible for funding from other federal and state funding programs subject to the rules of the other programs, furthering our responsibility to coordinate with other agencies to maximize the deployment of high-quality broadband service across the United States.<sup>6</sup> To promote the efficient use of broadband funding, a number of funding programs make areas ineligible for broadband deployment funding where a service provider is already subject to an enforceable commitment

to serve.<sup>7</sup> Our announcement avoids leaving these areas unserved for the duration of the RDOF deployment terms,<sup>8</sup> because providers may now have access to alternative funding to serve these areas.

These carriers remain subject to all eligible telecommunications carrier (ETC) obligations unless and until they follow the relevant procedures to relinquish their designations.<sup>9</sup> Additionally, they cannot discontinue voice service without Commission approval.<sup>10</sup>

*Co-Mo Connect Defaults and Additional Charter Defaults.* In Appendix A, we provide a list of all the additional RDOF eligible census blocks contained within the CBGs that Charter will not serve in Michigan, Missouri, Oregon, and Wisconsin, and the RDOF eligible census blocks contained within the CBGs that Co-Mo Connect will not serve in Missouri. In addition, we will also update the Broadband Funding Map to remove these census blocks from Charter and Co-Mo Connect's service areas.<sup>11</sup> Below, we provide a limited waiver of the Commission's non-compliance rules to adjust support to reflect that these areas will not be served. Charter and Co-Mo Connect otherwise remain subject to RDOF non-compliance measures for failure to meet the terms and conditions of support, including support recovery for all unserved locations at the end of the deployment term.<sup>12</sup> We will continue to use the available tools to monitor Charter and Co-Mo Connect's compliance with the applicable deployment obligations in their

remaining supported service areas.<sup>13</sup>

While Charter and Co-Mo Connect notified the Commission that they will not serve the identified census blocks, Charter and Co-Mo Connect are not withdrawing from RDOF. The RDOF support program rules do not provide for partial withdrawals from the program. The Commission takes compliance with the terms and conditions of its high-cost programs seriously and imposes non-compliance measures if the requirements are not met.<sup>14</sup> Charter and Co-Mo Connect remain subject to the program rules, including the applicable non-compliance measures,<sup>15</sup> for the duration of the support term except as explained below, and remain committed to serve the eligible census blocks within the remaining CBGs in their supported service areas with voice and broadband service meeting program requirements.

On our own motion, we find good cause to waive in part sections 54.320(d) and 54.806(c)(1) of the Commission's rules for the census blocks identified in Appendix A consistent with precedent,<sup>16</sup> and instruct the Universal Service Administrative Company (USAC) to stop paying support for the identified census blocks pursuant to section 54.320(c) of the Commission's rules.<sup>17</sup> Generally, the Commission's rules may be waived for good cause shown.<sup>18</sup> Waiver of the Commission's rules is appropriate only if both: (1) special circumstances warrant a deviation from the general rule, and (2) such deviation will serve the public interest.<sup>19</sup>

Despite our limited waiver, which is narrowly limited to stopping payments of future support for the identified census blocks, Charter and Co-Mo Connect otherwise remain subject to section 54.320(d) and 54.806(c)(1) of the Commission's rules.<sup>20</sup> If Charter or Co-Mo Connect fail to meet their interim service milestones by not serving the required number of locations based on their original authorized location totals, they will be placed in the associated non-compliance tier.<sup>21</sup> If the applicable non-compliance tier requires that we withhold an amount of support that exceeds the amount of support we

have stopped paying for the identified census blocks, we will withhold an amount of additional support that equals the difference between: 1) the amount of support required to be withheld pursuant to section 54.320(d)(1), and 2) the amount of support we stopped paying for the identified census blocks.<sup>22</sup> If the applicable non-compliance tier requires that we withhold less support than the amount of support we have stopped paying for the identified census blocks pursuant to our limited waiver, we will make no further adjustments to Charter's or Co-Mo Connect's monthly disbursement, i.e., we will withhold no support other than the support we stopped paying for the identified census blocks.<sup>23</sup> At the end of the deployment period, we will apply section 54.806(c)(1) to recover support for all unserved locations, including the locations covered by the identified census blocks.<sup>24</sup> Any additional issues related to the support recovery required by section 54.806(c)(1) of the Commission's rules will be addressed in a separate release.<sup>25</sup>

*CCTC.* We consider CCTC to have defaulted on its RDOF service milestones in Texas. CCTC will receive no further RDOF auction support payments<sup>26</sup> and is subject to support recovery and non-compliance measures consistent with the Commission's rules.<sup>27</sup> We will also remove its RDOF service areas from the Broadband Funding Map.

*Charter's Requested Correction.* We grant Charter's request to issue a correction to the *Charter Post-Authorization Default Public Notice* to remove from its previous list of defaulted CBGs, 16 CBGs in Michigan, Missouri, and Wisconsin.<sup>28</sup> Charter claims that the 16 CBGs were "inadvertently included"

when it notified the Commission of certain CBGs it did not intend to serve.<sup>29</sup> Consistent with the FCC's coordination with our sister federal agencies and state broadband offices concerning federal broadband deployment funding, the Bureau consulted with each of the affected state broadband offices, along with staff from NTIA, RUS, and the U.S. Treasury, and confirmed that this correction will not result in duplicate funding, necessitate changing the results of a challenge process that has been finalized, or lead to overly burdening the administration of other broadband funding programs due to the Bureau's prior announcement regarding defaults on the eligible census blocks within these CBGs. Appendix B reflects Charter's requested correction and we have added these census blocks back to Charter's service areas in Michigan, Missouri and Wisconsin. We will also correct the Broadband Funding Map to add these census blocks back to Charter's service areas.<sup>30</sup> As a result, Charter again has an enforceable commitment to serve the census blocks in Appendix B pursuant to its RDOF obligations.

We urge all carriers to conduct thorough due diligence prior to notifying the Bureau of any defaults to ensure they are correctly identifying the CBGs where they plan to default. Failure to timely provide accurate information about areas covered under a default could leave these areas without federal deployment funding.
