Upgrade Paths for HealthShare Solutions 2024.1

- To upgrade to this release from a version that is not listed, you must first upgrade to the most recent supported upgrade version, validate the upgrade, and then upgrade again to the target version. For example, a customer on UCR version 2019.1 should upgrade to HS 2023.2 as an intermediate version and then upgrade to the current version.
- This version of HealthShare does not support a migration path between a kit-installed instance and a container-based deployment.
- For 2024.1 only, container-based mirrored deployments must break their mirror before the upgrade and re-enable again it after the upgrade. ISC internal reference HSIEO-10657.
