

0. Introduction

A symbol is a unique identifier of a WTO official document. Based on the WTO Document Nomenclature (or classification scheme), the symbol can be more or less complex according to the series in which the document is being issued, its subject or its type.

The document symbol can be found in the header of the document.



Each symbol is made up of a combination of letters, numbers, and suffixes; typically, the symbol can be broken down into five/six main elements:

A collection is a broad grouping of individual document series. Each collection is made up of certain classes of documents which share a common framework called series. The type refers to the form or structure in which the content is presented followed by a number to indicate a sequential order and the status, a suffix to denote the condition of a document.

Three letter ISO standard codes are also used to identify Members (e.g., POL for Poland, IND for India, etc.).
