

**RESOLUTION NO. 654  
RESOLUTION OF THE COUNTY COUNCIL OF DORCHESTER COUNTY,  
MARYLAND TO AMEND THE COUNTY'S SCHEDULE OF FEES**

WHEREAS, the County Council of Dorchester County, Maryland agreed to separate the County's fee schedule from the 2012-2013 Annual Budget and Appropriation Ordinance of Dorchester County and from future Budget and Appropriation Ordinances on May 15, 2012 in order to allow the opportunity to make any changes or amendments to this schedule, if necessary, periodically throughout the fiscal year;

WHEREAS, the County Council for Dorchester County, Maryland enacted its 2014-2015 Annual Budget and Appropriation Ordinance of Dorchester County for the fiscal year ending June 30, 2015 by Bill No. 2014-6 and recognized this schedule of fees supports the purposes identified in that ordinance in amounts as specified herein;

WHEREAS, the County Council for Dorchester County, Maryland adopted Resolution No. 520 establishing this "Schedule of Fees," effective beginning July 1, 2012 and ending June 30, 2013;

WHEREAS, the County Council for Dorchester County, Maryland, has adopted resolutions since the establishment of this "Schedule of Fees," to change various fees, the last being Resolution 639 adopted on May 18, 2021;

WHEREAS, the County Council for Dorchester County, Maryland, has adopted resolutions since the establishment of this "Schedule of Fees," to change various fees, the last being Resolution 646 adopted on June 14, 2022;

WHEREAS, the County Council for Dorchester County, Maryland, wishes to amend the County Schedule of Fees to change various fees for various County services, effective beginning on July 1, 2023 and ending on the 30th day of June 2024; and,

NOW, THEREFORE, the County Council for Dorchester County, Maryland, does hereby adopt the following Schedule of Fees that incorporates these amendments:


