

I have served on the Alaska Court of Appeals since March 2021 and this is my first retention election. The function of an appeals court is to serve as a safety valve in the justice system, assuring litigants that any serious errors in their cases will be corrected, and to provide guidance to the trial courts, practicing attorneys, and the public regarding the correct interpretation and application of the law. I am profoundly conscious of the fact that criminal cases have significant impact on everyone involved -- defendants, victims, family members, law enforcement officers, jurors, and ultimately the community -- and strive to render timely decisions that reach a just result and correctly apply and succinctly explain the law.

I have spent my entire professional career in public service with a focus on the administration of criminal justice. My current service as a judge has been both the most challenging and rewarding work I have undertaken in my 34 years in the law. If retained it would be a tremendous honor and privilege to continue serving the people of Alaska.
