## Position Statement

Since 2020, I've had the honor and privilege of serving as a Superior Court Judge in Anchorage, primarily presiding over civil matters. The caseload is diverse, which makes the job incredibly interesting. I preside over complex civil litigation matters, family law cases, child protective cases, probate cases, administrative appeals, involuntary mental health commitments, and occasionally criminal jury trials.

With this varied caseload, it's important that I'm prepared for each hearing to ensure I'm serving the parties to the best of my abilities. I'm committed to ensuring my courtroom is a place where parties can present their cases, to listen to their positions respectfully, and to apply the law fairly and impartially without regard to my own preferences.

Since 2023, I've also presided over the Felony Drug & DUI Therapeutic Court. This court is particularly rewarding because the therapeutic court model is so different from traditional court proceedings. I'm part of a group of professionals who work collaboratively in order to help our participants identify the root causes of their actions that brought them into court in the first place. I work with a team of District Attorneys, Public Defenders, Probation Officers, Treatment Providers, and other Court staff to assist those who appear before me.

It has been a tremendous honor to serve the people of my hometown and of the State of Alaska and I'm respectfully asking you to vote to retain me as a Superior Court Judge so I can continue serving.
