RE: Voter Education and Outreach: High School Voter Education  
Weeks, September 16-27, 2024

California Education Code section 49040(a) designates the last two full weeks in April and September as High School Voter Education Weeks. This provides an opportunity for high schools and their students to partner with county elections officials to promote civic education and participation. As elections officials prepare for local elections and the November 5, 2024, General Election, now is a great time to encourage students to pre-register to vote and become engaged and active in their communities. It's also a great time to encourage schools to participate in the 2024 [California Student Mock Election](#), which takes place on October 8, 2024. Registration for the Mock Election is open through October 2, 2024. Students who participate will gain firsthand knowledge of the issues, the value of voting, and how democracy works.

California Secretary of State Shirley N. Weber, Ph.D., in partnership with California Superintendent of Public Instruction Tony Thurmond, issued a letter encouraging all California high schools to participate in High School Voter Education Weeks, September 16-27, 2024. Please feel free to use this letter as a tool to gain support and recognition from your Board of Supervisors or County Board of Education.

Dear County and District Superintendents, Charter School Administrators, and High School Principals:

### High School Voter Education Weeks (September 16–27, 2024)

As educators, it is important to ensure that students learn how to become active participants in our democracy. It is never too early to motivate students to be involved. We encourage your school district and campuses to participate in the 2024 High School Voter Education Weeks during September 16–27, 2024. The goal of these weeks is to (1) bring civic awareness to young, future voters and (2) inspire eligible students ages 16–17 to pre-register to vote so they will automatically be registered when they turn 18 years old. Since the California pre-registration program launched in September 2016, nearly 1.2 million students have pre-registered to vote, which accounts for 1,141,476 eligible voters.

The California Secretary of State's office can provide resources and support, and county election officials can serve as partners to make it easy for schools to participate in the democratic process.

Below is a list of online resources and other ideas to support your school in sharing the information with your students and families.

- **Poll Workers:** Another way students can engage in the democratic process is to participate as poll workers during election season. With the passing of Senate Bill 955 (Chapter 921, Statutes of 2022), California students in grades 6 through 12 are eligible to receive one excused absence per year to participate in a civic or political event, provided the student notifies the school ahead of the absence. ### Additional Civic Engagement Ideas

- **Student Mock Election:** Encourage schools to participate in the California Student Mock Election. Registration for the Mock Election is open until October 2 and will take place on **Tuesday, October 8, 2024**. Participating in this Student Mock Election is a great way for educators to provide relevant and active learning experiences about voting and the civic process.
