## **III. PUBLIC TESTIMONY**

From: Mary Smart Mililani Town resident

For: February 23, 2022 Reapportionment Meeting

This is the first time I have followed Hawaii's Reapportionment process closely. I began thinking that the provisions of the Hawaii Constitution on Reapportionment would be followed and that input from Hawaii voters would not only be considered but also integrated into the draft plans. I was wrong.

I was impressed with the community input and all the effort put into drawing maps that met Constitutional criteria better than the maps developed by the Commission's Technical Committee. Since no explanation was given for some of the Technical Committee's convoluted district lines, it can be perceived that incumbent residences played a significant role in drawing district lines, which would be a violation of Hawaii's Constitution that mandates not to advantage a person or political faction.

Another disappointment was the extraction process that actually extracted permanent residents who live on military bases and permanent residents who happen to be married to military members who claim a domicile outside of Hawaii. No other state extracts numbers from the census to conduct reapportionment. Therefore, those numbers extracted are people who end up without representation anywhere. They are completely disenfranchised by Hawaii's process. In fact, Hawaii extracts them whether it can be confirmed that they participated in the census or not, whether they reported a Hawaii address or not. This extraction also negatively affects all the permanent residents who live on the military bases, in neighborhoods near military bases and the Representative from that district. In some cases the military numbers called for more extractions than lived in the census tract. The extraction process is not precise and must be corrected before the next reapportionment cycle. House Bill SB3254 is currently being processed in the Legislature to correct these problems and needs to pass. The Senate Ways and Means Committee is hearing it on Thursday February 24, 2022 at 10 am.

The commission heard over and over that communities wanted the redistricting plans to keep their communities intact, contiguous, and compact per the Hawaii Constitution. In some instances the Commission listened. I was disappointed that the requests of Mililani residents fell on deaf ears thus far. In my testimony I provided multiple maps showing Mililani Town, Mililani Mauka, and Waipio Acres as a community of interest. I recently found Board of Water Supply maps that show Mililani Town, Mililani Mauka and Waipio Acres are linked together. Mililani Mauka should not have been split in two during the 2<sup>nd</sup> iteration of maps. Mililani Town should be intact. Waipio Acres residents should be aligned with Mililani (Town or Mauka as needed). Kipapa Gulch is a natural boundary between Mililani neighborhoods and Waipahu.

If the Commission does not modify the current maps to unite these central Oahu communities, the next Reapportionment Commission should consider all the testimony from the 2021/2022 process before issuing any revised maps. The 2022 objectionable maps must not become a precedent that has permanence.
