



MESSAGE FROM THE PRESIDENT

Dear Colleagues,

It is my privilege to address you for the first time in my role as President of the Ontario Psychiatric Association. While I have been a member of the OPA since I moved to Ontario from Saskatchewan in 1989. I only fully understood the importance of the Association in the late 1990s when a few of my colleagues and I recommended broadening the committal criteria in the Mental Health Act and introducing community treatment orders. It quickly became apparent that these legislative amendments would never have been enacted without the leading role taken by the OPA. Many psychiatrists are unaware of the behind the scenes effort in an undertaking such as a major amendment of the Mental Health Act: including research, development of policy documents, professional lobbying and an active media campaign.

Whether it is advancing the interest of psychiatrists in discussions with the Ministry on details of Bill 171 (which sets up a College of Psychotherapy), or in fee negotiations, our strength comes through our size and by acting in unison. The OPA is the largest provincial psychiatric association in Canada. Indeed, with approximately 1600 psychiatrists in Ontario, our specialty is the largest in the province. Yet, sometimes we have "punched below our weight." The OPA has approximately 600 members. I believe that our failure to recruit the majority of Ontario psychiatrists to OPA membership has led others, and sometimes even ourselves, to not pay sufficient attention to the Association.

One of my goals is to recruit an additional 200 members during my presidency. You will see some promotional material, which will be rolled out later in the year that has been developed to catch the attention of our younger colleagues.

However, the most effective recruiting strategy will always be encouragement from other colleagues to join *our* Association.

One of the roles of the OPA is to provide quality continuing professional development. This year, the Fall Psychotherapy Conference will feature Dr. Mark Solms speaking on Neuropsychoanalysis and will be held on October 20th at the George Ignatieff Theatre, Trinity College. The Annual Conference will be held at the Marriott Eaton Centre Hotel on February 8th and 9th, 2008. Council is aware that the Annual Meeting needs to be revamped and invigorated, and I will be working with the Continuing Education Committee to double the size of the meeting. Please hold February 8th and 9th in your 2008 calendar and also plan to attend the Gala Dinner Dance on February 8th. There are very few opportunities to meet with colleagues socially whether they work in the next office or in another city. Let's plan to do so at least once per year.

Last year, Dr. Susan Abbey initiated a series of visits and presentations in cities across the province. We received excellent feedback stating that this enabled our colleagues to better understand what the OPA does and to bring their suggestions to the Organization. I intend to continue these visits in the coming year. I look forward to seeing you through the year and at the Annual Conference. In the meantime, do not hesitate to contact me if you have questions or suggestions.

The T. A. Sweet Award

Presented to Mr. William J. MacPhee at the OPA Annual Dinner.

The T. A. Sweet Award is presented annually to individuals who have made a major contribution to the understanding of mental illness and its impact on individuals in society.

The OPA is delighted to announce this year's recipient was Mr. William J. MacPhee.

William J. MacPhee was diagnosed with schizophrenia in 1987. After years of struggling with this devastating illness, Mr. MacPhee was able to regain control of his life through medication, family support and other therapies.

Recognizing the need for an informative publication, he formed Magpie Publishing Inc. and in 1994 launched Schizophrenia Digest. He has overseen the growth of the magazine to a professional, quarterly publication. In 2003, Mr. MacPhee addressed the needs of the approximately 2.5 million Americans who suffer from schizophrenia. At that time, a U.S. Edition of Schizophrenia Digest was launched.

Mr. MacPhee is a strong advocate in the area of mental health and is often called upon to speak to mental health and consumer groups throughout Canada and the United States. He speaks candidly about the crippling effects of schizophrenia and describes with great clarity and detail what it is like to be paranoid, have hallucinations, become frustrated, depressed and suicidal. He also offers hope, showing that with the proper medication and support, recovery and a return to daily living are possible.

The OPA was pleased to recognize Mr. MacPhee at the OPA Annual Conference held this past February. Mr. MacPhee's presentation was inspirational and for those in attendance it gave a uniquely personal insight into the day-to-day challenges of those with Schizophrenia.



Case Vignette

In this edition of *Dialogue* we are introducing a new section - Case Vignette.

These are actual cases from Ontario psychiatrists and the vignettes are intended to highlight real life experiences and challenges of our colleagues, along with take away messages. If you have a Case Vignette you would like included in *Dialogue*, please submit the case for consideration by the publisher. It is imperative that any case not violate confidentiality.

Mrs. R.K. is a 62-year-old widowed grandmother of three who presents to the ER with recent onset chest pain, shortness of breath, palpitations, light headedness and diaphoresis. Her medical history is significant for hypothyroidism and hypertension. She reports no antecedent psychiatric history and good exercise tolerance. She experienced a normal grief reaction seven years earlier following the sudden death of her husband. She was evaluated by the ER doctor and reviewed by the cardiologist before being consulted by psychiatry for "GAD and panic of recent onset".

Obviously an organic cause, medication or substance would need to be excluded after a much more detailed history is provided. A late onset anxiety disorder is sufficiently atypical to raise a flag of suspicion. This pleasant lady was being treated with Eltroxin 50mcg, HCTZ 25mg po QAM. Her thyroid, parathyroid, pituitary, adrenal and metabolic status were grossly normal. A urine drug screen was wisely ordered and negative. After twice denying alternative treatments she conceded that she had started a preparation given to her by her sister following a trip to Europe. This correlated with the onset of her symptoms. It took some effort to clarify the tincture was Nux Vomica and that it contained Strychnine. She discontinued this preparation and her symptoms resolved within 24 hrs.

Depression, anxiety and mood disorders are ranked on the list of conditions in which alternative or complementary therapies are often utilized. According to the New England Journal of Medicine, less then 40% of patients volunteer this information. Other reports indicate physicians ask only 20% of the time. The take away message is that it is common and may have significant adverse effects if not identified. Patient's anticipated criticism and perceived harmlessness is the rationale for silence.

The Prime Clinic ~ For People at Risk for Psychosis

The PRIME Clinic is dedicated to the early identification and treatment of young people ages 12 to 30 who are at risk of developing psychosis. PRIME is one of the leading clinics in North America in studying possible ways to prevent or delay the onset of psychosis.

Individuals referred to PRIME are young people who have become distressed by changes in their thoughts, perceptions, and feelings. Mental and emotional changes are early signs that someone could be at risk for psychosis and often occur before more serious symptoms develop. These changes may be vague or barely noticeable and are often difficult to describe to others.

Signs include:

- Trouble concentrating or thinking clearly
- Trouble understanding what is heard or read
- Confusion about what is real or imaginary
- Hearing voices or seeing things that aren't really there
- Feeling that the world has become strange and unreal
- Preoccupation with religion or superstitions
- Feeling suspicious or paranoid
- Disorganized speech, racing thoughts or slowed-down thoughts
- Irrational ideas of special identity or abilities
- Problems with social activities, at work or at school
- Withdrawal from family and friends
- Flat emotions, decrease in facial expressions, monotone speech

While in the past it was common to delay active treatment until clear and obvious signs of psychosis appeared, recent research has focused on the outcome of very early detection and intervention. These early studies are exploring the possibility that if we recognize and treat clinical high risk youth as early as possible, the onset of psychosis can possibly be delayed or even prevented. At the least, early identification can minimize the duration of untreated psychosis.

Through our research and clinical program PRIME offers a range of treatment options to clients aimed at decreasing symptoms and strengthening coping strategies. The PRIME clinic is located at 252 College Street, a Victorian house adjacent to the College Street site. This non-institutional environment facilitates engagement and participation and is more amenable to the clients and families we help.
