## MINUTES OF THE STATE ETHICS COMMISSION MEETING

October 22, 2020

The meeting convened at 9:00 a.m. at 45 Calvert Street, Room 164 in Annapolis. Those listed as present participated in all portions of the meeting unless otherwise noted. If other individuals participated in aspects of the meeting, they will be identified in the specific line item where their participation occurred.

**ITEM 1**: Tentative Agenda

<u>Discussion:</u> The Commission reviewed the tentative agenda.

<u>Decision:</u> The tentative agenda was approved as adjusted.

ITEM 2: Minutes of the August 20, 2020 Meeting

Discussion: The draft minutes of the August 20, 2020 meeting were reviewed and discussed.

Decision: The draft minutes were approved.

**ITEM 3:** Financial Disclosure Exemption Request

<u>Discussion:</u> Ms. Allgair briefed the Commission on the Chesapeake Bay Bridge Reconstruction Advisory Group; Equine Health, Safety, and Welfare Advisory Committee; Task Force on the Economic Future of Western Maryland; Stakeholder Workgroup on the Maryland Loan Assistance Repayment Program for Physicians and Physicians Assistants; and the Community Benefit Reporting Workgroup requests for exemption from the financial disclosure requirement.

<u>Decision:</u> The Commission granted exemptions for the Chesapeake Bay Bridge Reconstruction Advisory Group, Task Force on the Economic Future of Western Maryland and Stakeholder Workgroup on the Maryland Loan Assistance Repayment Program for Physicians and Physicians Assistants.

The Commission did not grant exemptions for the Equine Health, Safety, and Welfare Advisory Committee nor the Community Benefit Reporting Workgroup.

<u>ITEM 4:</u> Financial Disclosure Additions and Deletions

<u>Discussion:</u> Ms. Allgair presented a listing of the proposed additions and deletions to the financial disclosure list recommended by State agencies and reviewed by Financial Disclosure Administrator, Young Smith and Executive Director, Jennifer Allgair. The recommendations covered the Maryland Office of the Inspector General for Education, Department of the Environment, Community College of Baltimore County, University of Maryland Global Campus, Maryland Port Administration, Department of Health, Department of Transportation, Maryland Energy Administration and the Maryland Transportation Authority.

Decision: The Commission approved Ms. Allgair's recommendations.

<u>Decision:</u> The Commission determined virtual meetings would not be considered "in the presence" but lobbyists should be aware that any expenses relating to virtual meetings would count towards the expense triggers for "not in the presence" communications.

<u>ITEM 27:</u> Informal Matter – University of Maryland, Baltimore (20-0442)

<u>Discussion:</u> Ms. Krogen briefed the Commission on a secondary employment request regarding an employee at the University of Maryland, Baltimore wanting to serve as a board member for a national alliance.

Decision: The Commission granted an exception to allow this secondary employment.

<u>ITEM 28:</u> Informal Matter – Department of Human Services (20-0431)
