ITEM 1: Introduction of New Staff

<u>Discussion:</u> Ana Henry and Jill Byzcek were introduced as the new Assistant General Counsel and Legal Assistant/Paralegal, respectively.

ITEM 2: Tentative Agenda

<u>Discussion:</u> The Commission reviewed the tentative agenda.

Decision: The tentative agenda was approved as amended.

ITEM 3: Minutes of the September 22, 2021 and October 12, 2021 Meetings

<u>Discussion:</u> The draft minutes of the September 22, 2021 and October 12, 2021 meetings were reviewed and discussed.

<u>Decision:</u> The draft minutes were approved.

ITEM 4: Minutes of the June 10, 2021 Meeting

<u>Discussion:</u> Changes to the minutes of the June 10, 2021 meeting were reviewed and discussed.

<u>Decision:</u> The change to Item No. 4 from the minutes of June 10, 2021 were approved

ITEM 5: Boards and Commissions - Executive Unit Determination

<u>Discussion:</u> Ms. Allgair briefed the Commission on whether or not the Maryland Commission for the Innovation and Advancement of Carbon Markets and Sustainable Tree Plantings should be considered an executive unit covered by the Public Ethics Law.

<u>Decision:</u> The Commission determined that the Maryland Commission for the Innovation and Advancement of Carbon Markets and Sustainable Tree Plantings was an executive agency and its members are public officials covered by the Ethics Law.

**ITEM 6:** Financial Disclosure Exemption Request

<u>Discussion:</u> Ms. Allgair briefed the Commission on the requests for exemption from the financial disclosure requirement from the Maryland Health Benefit Exchange Standing Advisory Committee and the Task Force to Study Canine Breeding Facilities and Sourcing Standards.

<u>Decision:</u> The Commission granted exemptions for the Maryland Health Benefit Exchange Standing Advisory Committee and the Task Force to Study Canine Breeding Facilities and Sourcing Standards.

<u>Decision:</u> The Commission approved Ms. Allgair's recommendations.

The Commission did not receive any comments on the proposed regulations during the public comment period. The Commission held a general discussion of the regulation changes that affect local governments which include quasi-governmental entity definition and disclosures, attributable interest, changes to the gift provisions, additional financial disclosure requirements and a prohibition on retaliation provision.
