Message From Our Executive Director

Dear friends,

2022 was a year of changes for the Connecticut Council on Problem Gambling. The restrictions set in place due to COVID finally began being lifted and people started to return to a version of normalcy. In addition, online gambling, first implemented in the fall of 2021, was fully in effect resulting in a sustained increase of calls/chats to our Problem Gambling Helpline.

The primary focus of our advocacy before the Connecticut General Assembly resulted in the successful passage of legislation enabling a prevalence study of gambling across the state. With online gambling now a fully codified reality, this new data is sorely needed to understand the scope and impact of the expansion. The initiative was fully funded and tasked the Department of Mental Health and Addiction Services with commissioning a study.

The Council saw itself grow and change in 2022. After having had to reduce our staffing levels at the onset of the pandemic, we were able to expand our team once again by hiring a training and prevention coordinator and a helpline coordinator. After our team successfully demonstrated its ability to work remotely, we decided to continue the model and were able to get out of a costly lease and move to a much more streamlined office space in the Non-Profit Center in Hartford. That money, that for many years went to an expensive overhead, can now be redirected towards programs to help those adversely impacted by problem gambling. Our Board of Directors saw significant change as well. After many years of leadership, Dr. Willie Coleman has stepped down as President and Dave Fleming has assumed the role. We were fortunate to see several new board members volunteer to be a part of our organization that brought new experience in legal and veterans' issues among their diversified skill sets.

CCPG continued to offer a robust slate of training initiatives for those interested in learning about gambling related issues. The College Campus Gambling Initiative saw several Connecticut colleges and universities accept funding to incorporate problem gambling prevention strategies. The Fox 61 Student News Program saw several submissions into our "Not Just a Game" category where students develop news stories on gambling related issues. Our Powered Up Professional training sought to raise awareness regarding the correlation among gaming and gambling and enable parents and others influential to youth to begin to have conversations on the topic. Our 19th Annual Conference, hosted in Glastonbury, was almost filled to capacity, and featured an exciting group of presenters.

Lastly, we maintained our strong relations with our gambling industry partners, Foxwoods Resort Casino, Mohegan Sun, the Connecticut Lottery, and Sportech. We also successfully developed relationships with the new providers, Wondr Nation, DraftKings, FanDuel, and Rush Street Interactive, that have begun operating in our state since the implementation of online gaming.

I'm proud of the work that the Connecticut Council on Problem Gambling has done this year to strengthen the state's Problem Gambling Safety Net. I'm optimistic about the future for our organization and our mission to share responsible gambling strategies to those that choose to gamble and to always be here for those that are adversely affected by gambling related harms to help them on their road to recovery.

Programs & Services

Problem Gambling Helpline: Provides free support, resources and referrals to counseling, 24 hours a day, 7 days a week, to individuals or those impacted by gambling related harm (available via phone, text & chat). From the launch of online gambling offerings in October the calls/chats to the helpline increased significantly. Compared to the year before, calls/chats/texts increased 91%, with a 76% increase in calls and a 620% in chats.

Training: in 2022 CCPG offered a total of 37 trainings where 1184 people took the opportunity to increase their knowledge and awareness of problem gambling, as well as ways to integrate these concepts into their work.

Outreach: CCPG staffers hosted resource tables at many events such as the CCAR Recovery Fest, Department of Veterans Affairs Annual Stand Down, Recovery Celebrations, Vets Rock Event at Mohegan Sun Casino. and Yard Goat Games

The College Campus Gambling Prevention Initiative provided grants to 9 CT Colleges and Universities. With this funding, campuses implemented activities utilizing the Strategic Prevention Framework (SPF) to increase awareness that gambling is not a risk-free activity. Strategies include policy change, surveys, focus groups, integration of gambling materials at wellness events and trainings with RA's, Public Safety, students and staff.

The Fox61 Student News Program provided training and scholarships to students submitting news stories in the category of "Not A Game" discussing Gambling as a co-occurring disorder and potential risks to youth.

CCPG was proud to partner with the Capitol Region Education Council (CREC), and DMHAS Problem Gambling Services (PGS) on the Gambling Awareness Youth Media Project which provided training to middle and high school students including types of gambling, warning signs, risk factors and resources. Students utilize the information learned to create campaigns to educate their peers and communities.

The Powered-Up Program provided information about gaming to parents and young people across the state. Through the Powered Up Professional Program, CCPG trained Prevention Specialists and Behavioral Health Providers around the topics of healthy gaming. CCPG staff provided support in facilitating conversations to educate communities they serve about healthy gaming, boundaries and the convergence between gaming and gambling.

S.B. No. 140 (RAISED) AN ACT CONCERNING STUDIES OF THE EFFECT OF LEGALIZED GAMBLING IN THE STATE.

Sen. Osten, Rep. Horn and Members of the Committee: Thank you for the opportunity to testify on this bill to study the effect of legalized gambling. My name is Diana Goode, Executive Director of the Connecticut Council on Problem Gambling (CCPG).

Connecticut has approximately 3,565,000 citizens. That means that over 100,000 citizens and over 275,000 family members are negatively impacted by gambling every day. Using current population models, gambling related problems directly affects 735 individuals and 1,911 family members in each House district and 3,056 individuals and 7,946 family members in each Senter district.

It is our strong recommendation that the state, through a neutral organization or institution of higher education, conduct surveys of the previousne of gambling eleted harm, this is especially necessity given the new landscape after the expansion of legalized gambling (a. s, sports betting, online wagering, casino expansion) and at regular periods thereafter to monitor impacts and how date that will support evidence based mitigation efforts. Data collected by regulated operators on gambling activity should be made publicly available through the regulatory agency to quantifier researchers to help support mitigation efforts. To afleguated consumers, this data should be encrypted and de-identified to remove personally identifying information, consistent with federal and state privacy, intellectual property, and freedom of information laws.

The bill language calls for the study of gambling activity engaged in by the public and the desirability of expanding, maintaining, or reducing the amount of legalized gambling permitted in this state. We feel that the study and collection of this data must be conducted by an independent provider that isn't affiliated with the gaming industry to completely ensure impartiality.

While the CCPG does not advocate for or against gambling, we feel that it is necessary to ensure that the state has a robust problem gambling safety net to help those inclividuals and families impacted by problem gambling and to reduce harms. Additionally, the need to educate those that choose to gamble about responsible gambling strategies is vital to resuring that those consumes have the inovivedeg at other disposal to play refer. The 2022 legislative session was one of the shortest in the last few decades. Even with those tight deadlines, CCPG has remained busy advocating for the interests of problem gambling community by meeting with legislators and testifying on bills before the Public Safety, Public Health, Insurance, and General Law Committees. Most importantly, CCPG was instrumental in advocating for a fully funded study on the effects of legalized gambling throughout the State of Connecticut. The data will be crucial in helping direct programs and resources in the future, especially with the implementation of online gambling last year.



Responsible Play



In 2021, CCPG working in partnership with Foxwoods Resort Casino. Mohegan Sun, the Connecticut Lottery, and Sportech designed and launched a statewide marketing campaign: Responsible Play – The CT Way. Providing responsible gambling tips and strategies to Connecticut residents that chose to gamble. Throughout 2022 the campaign was expanded. CCPG completed a major upgrade and redesign of the Responsible Play website. Foxwoods, Mohegan Sun, and Sportech have used the images in posters, brochures, digital displays, and employee educational materials throughout the respective facilities. The Connecticut Lottery has placed the new logo on its various terminals, digital vending machines, retail counter mats, the organization's website, in billboards, and in employee educational trainings. The Responsible Play Campaign was selected as a Finalist for the AGA's Responsible Gaming Award!



CCPG In The News









The expansion of online gambling in October of 2021 led to a significant increase in calls and chats to CCPG's Problem Gambling Helpline. We saw a a shift of callers from those who frequent casinos to college aged males that were using online sports betting platforms. CCPG was often in the news as the media sought to understand the impact of the gambling expansion on the citizens of Connecticut. Heavy advertising by the gambling platforms, especially around major sporting events led to frequent calls to us for interviews to describe resources available in Connecticut and to share responsible gambling tips.
