## AGRICULTURAL PEST CONTROL PILOT 2024 REGISTRATION INFORMATION (Apprentices and Journeymen)

---

### AGRICULTURAL PEST CONTROL AIRCRAFT PILOTS

All Agricultural Pest Control Pilots (both Apprentice and Journeymen) are required to register with the Agricultural Commissioner/Weights & Measures of the county in which they intend to perform pest control.

### APPRENTICE PILOTS

Section 6542 of the California Code of Regulations requires that Apprentice Pilots include on their registration the name of the Journeyman Pilot responsible for the supervision of the Apprentice's pest control activities. The Journeyman named must be registered in Los Angeles County. In the event the Journeyman is no longer available to provide supervision, the Agricultural Commissioner must be notified, and the registration amended.

### REGISTRATION PROCESS / FEE

If Los Angeles is your home county or first county with which you register, the **application fee is \$10.00** and must be submitted with the application. **Each pilot must register by mailing in your application.**

If you have already registered in another county, **the fee is \$5.00, and you must register by mailing in your application.** Each pilot must submit a complete Pest Control Aircraft Pilot Registration Application, obtained from, and printed by, your home county.

### IMPORTANT INFORMATION

#### **Notice of Intent**

As a condition of registration, you, or your company, are required to provide this department with a 24-hour notice of intent for all aerial applications of restricted and non-restricted pesticides.

#### **Monitoring an Aerial Application of a Non-Restricted or Restricted Pesticide in Los Angeles County**

All aerial applications in Los Angeles County shall be monitored by this department.

#### **Registration Renewal**

To register, registrants must fill out and return the registration application with the appropriate fee. A penalty of \$5.00 is assessed on all renewal requests received after January 31, 2024.
