For email correspondence to carry out the activities that FRA undertakes in the context of the organisation of this meeting, FRA uses <u>Microsoft Office 365</u> cloud-based services. Therefore, Microsoft Ireland acts as FRA processor for this purpose.

Moreover, the travel agency AMEX will act as FRA processor.

We collect the personal data of experts invited to and participating in the Expert meeting on fundamental rights and environmental protection. The meeting takes place in Vienna at FRA on 16 November 2023 from 10.00-17.00 CET. The meeting will be in hybrid format with experts participating in person at FRA but also experts participating online.

Via email correspondence we will collect personal data to allow FRA to organize the travel and accommodation of experts participating in person in the meeting and/or the payment of reimbursable costs in line with the FRA <u>mission guide</u>;

For the organization of the expert meeting, including the travel and accommodation as well as catering arrangements, FRA and its travel agency AMEX (as FRA's processor) might collect from you the personal data described in section 5 via email correspondence with the experts and via the travel agency online booking tool "Neo" (see data protection notice here). Through email correspondence you will provide FRA with the information allowing us to book your flight and accommodation and – where applicable – to reimburse your travel expenses (e.g. since the travel agency cannot book train tickets, experts who travel by train to/from Vienna will be reimbursed by FRA for their travel expenses).

For the organisation of the hybrid meeting, the Agency uses the following cloud-based services on the basis of the inter-institutional framework contract for the provision of M365 services, of which the Agency is a part:

• MS Teams (as the online platform to carry out the hybrid meeting)



- FRA DMS SharePoint to maintain FRA list of invited experts and participating experts and any other meeting documents such as agenda, background documents or minutes.
- The FRA Environmental Protection mailbox (environment@fra.europa.eu) for centralizing all email communications related to this expert meeting. Therefore, some personal data (mainly metadata and diagnostic data) might be collected from you and processed by such applications as indicated in FRA's MS365 data protection notice.
