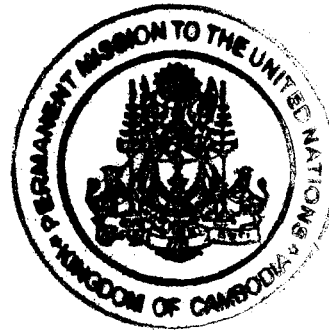

- Comprehensive Nuclear-Test-Ban Treaty, ratified 8 August 2000.
- International Convention for the Suppression of Terrorist Bombing, ratified 25 August 2005.
- Convention on the Marking of Plastic Explosives for the Purpose of Detection, ratified 25 August 2005.
- Convention on the Prohibition of the Development, Production, and Stockpiling of Bacteriological (Biological) and Toxin Weapons and on their Destruction.
- Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to be Excessively injurious or to have Indiscriminate Effects, ratified on 25 March 1997.
- Amended Protocol II to the CCWC, ratified on 25 March 1997.
- Protocol IV to the CCWC, ratified on 25 March 1997.
- Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on their Destruction, ratified on 8 February 2005.
- Treaty on the Non-Proliferation of Nuclear Weapons.
- Treaty on the Prohibition of the Emplacement of Nuclear Weapons and other Weapons of Mass Destruction on the Sea-bed and on the Ocean Floor and in the Subsoil thereof.

- Convention on the Physical Protection from Nuclear Substances, ratified on 29 August 2005.
- UN Convention on Combating Transnational Crime, ratified on 31 August 2005.
- Regional Cooperation Agreement on Combating Piracy and Armed Robbery in the Asian Sea.
- Memorandum of Understanding between the People Republic of China and ASEAN on Cooperation in the Field of Non-Traditional Security.

- **Collection and Destruction:** *(to be added: 223 units of Air-Surface Missiles A72 were destroyed in 2004 and 36 units of 125 M (SA-3), capable to cruise at the targets of 18 kilometers high, were destroyed in November 2005.*)
- **Partnership at Regional Level:** *(to be added: Cambodia has been appointed as Lead Shepherd Country on Countering Arms Smuggling of ASEAN during the 5th ASEAN Ministerial Meeting on Transnational Crime-Hanoi, Vietnam in 2005.)*
- **Seminar-Workshop:** *(to be added: Cambodia Co-hosted the International Conference on Small Arms Proliferation and Trade in the Asia Pacific in February 2000 and the ASEAN Regional Forum on Small Arms and Light Weapons in November 2005.)*
