# Information on confidence-building measures in the field of conventional arms

Kingdom of the Netherlands

2010

#### Introduction

The Netherlands attaches great value to disarmament and arms control as means to contribute to international peace and security. Confidence-building measures (CBMs) are deemed essential in this process, for they are important in reinforcing the norm against the spread of conventional weapons and in reducing tensions between states. CBMs provide transparency, dialogue and cooperation and therefore create a climate conducive to effective disarmament and arms control.

#### Dutch participation on Confidence Building Measures as a member of the OSCE

The Netherlands is a member of the Organisation for Security and Co-operation in Europe (OSCE). Part of the OSCE is the Forum for Security Co-operation (FSC), established in 1992. This is an autonomous decision-making body, subservient only to the OSCE Ministerial Council. Since its creation, the Forum has agreed on a number of documents and decisions on arms control, disarmament and confidence and security building measures (CSBMs).

The existing CSBM-regime now constitutes of interlocking exchanges of obligatory and verifiable notifications on military holdings and activities, and armed force levels. The CSBM regime contributes to greater transparency, and thus promotes trust and confidence among participating States. The Netherlands has fully implemented the following OSCE codes and principles, and adheres to the various regimes of information exchange described in these documents.
