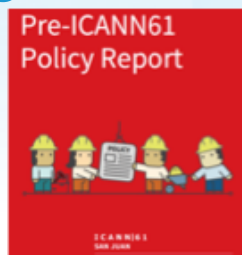

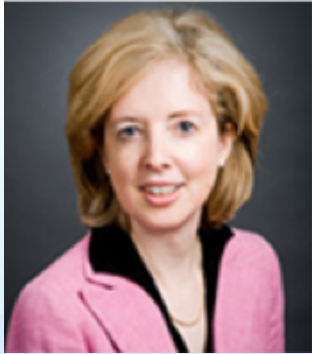

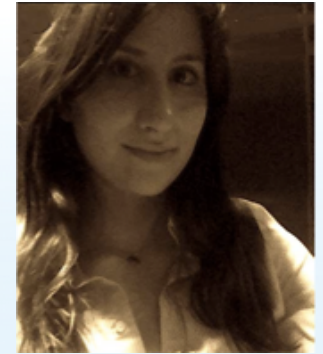

 - Meet with stakeholders, discuss the FY19 draft budget, make progress in Working Groups (WGs)
 - Regional At-Large Organization (RALO) Activities – NARALO – first North American School of Internet Governance and its 11th Year Anniversary; LACRALO – two days of meetings to discuss new governance documents; AFRALO – focusing on hot policy topics
- At-Large Review
