Submissions may be sent as an e-mail request to the Assistant Dean of Graduate Academic Affairs for review and approval by the Dean of GEPA. A request to extend the embargo must be received by GEPA at least two weeks prior to the date that the dissertation/thesis will be released. (Note: An embargo cannot be reinstated after the dissertation/thesis has been released.)*

**\*The following programs require a two-year embargo for all students: Biological Sciences, Biomedical Sciences, and Sociology.**

**Student Responsibility:** In addition to my approval of the copyright agreement with Proquest/UMI, I hereby grant a nonexclusive, worldwide, royalty-free copyright license to The Regents of the University of California ("University") to reproduce, distribute, and display my dissertation/thesis at the University of California San Diego ("the Work"), including: (i) the right to distribute the Work in whole or in part in all forms of media, now known or hereafter created, including display on the internet and through databases containing other works; and (ii) to electronically store, archive, copy and or convert the Work for preservation purposes. The Regents will credit me as the author of the Work.
