



# Inclusive Reporting: Examining Multi-Stakeholder Engagement in the VNR Process

### **Background**

The 2024 High-Level Political Forum (HLPF) is taking place amid complex global challenges, shaped by the overlapping crises of the COVID-19 recovery, conflict, and climate change. It is also situated amid several critical global moments, such as the SDG Summit in September 2023, which marked the mid-point towards the achievement of the SDGs, and the Summit of the Future (SotF) in September 2024.

The Voluntary National Reviews (VNRs) have emerged as a critical mechanism for tracking progress on the SDGs and fostering accountability among Member States. VNRs provide an opportunity for countries to showcase their achievements, share experiences, and identify challenges in SDG implementation, with stakeholder engagement remaining crucial to this process.

The VNR Lab, organized by the UN Foundation on the sidelines of the 2024 HLPF, aims to delve into the best practices and challenges of stakeholder engagement within the VNR process. Specifically focusing on Kenya, the VNR Lab will highlight the country's experience with multistakeholder reporting and the role of civil society in producing shadow reports alongside official VNR submissions. The session will feature a conversation between government officials, researchers, and other stakeholders to explore the role that civil society's capacity may play in driving and monitoring the SDG agenda through challenging times.

#### **Objectives**

- **Provide a platform** for Member States and stakeholders to discuss challenges, opportunities, and good practices in SDG reporting in the context of multiple global crises.
- Create an opportunity to spotlight examples of successful collaboration between Member States and stakeholders in support of measuring the SDG implementation and progress through VNRs.

• **Build momentum and synergy** around unique opportunities in 2024, such as the Summit of the Future, and maintain consistency with the commitments made at the 2023 SDG Summit.
