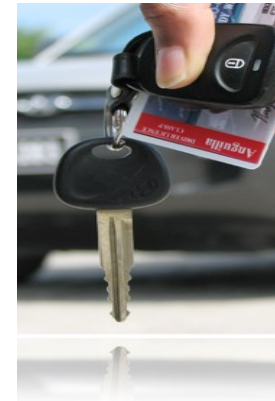

DRIVER'S LICENCE

LEARNING TO DRIVE

Before you become a road user, you must apply to the Traffic Department at the Police Headquarters for a Learners Permit. To apply you need a passport size picture and proof of identity (i.e. your passport or birth certificate). A fee of **EC\$65.00** is payable at the Inland Revenue Department.

- **Applicants must be sixteen years or older**

You must undergo a written examination prepared by the Traffic Department. A fee of **EC\$50.00** is payable at the Inland Revenue Department.

- **The Highway Code is a useful guide before taking the exam. It can be purchased for a fee of EC\$25.00.**

Once you have passed that exam, you can now apply for a road test at the Traffic Department at the Police Headquarters. A fee of **EC\$90.00** is payable at the Inland Revenue Department.

If successful, a certificate of competency is issued by the Traffic Department. This certificate should be presented at the Taxpayer Registration window at the Inland Revenue Department. Additionally, you will be required to complete an application for the issuance of a new Driver's Licence.

RENEWING YOUR DRIVER'S LICENCE

To renew your driver's licence, bring along with you your expired licence to the Inland Revenue Department, Taxpayer Registration window, and complete the application for the renewal of a Driver's licence form.

Your licence can be renewed for one year or three years, and valid for that period from the date of issue. Upon payment, a new photograph is taken if you so desire and a new licence card is prepared.

REPLACEMENT DRIVER'S LICENCE

Where a valid Driver's Licence has been lost or damaged, an application for the replacement of the Driver's licence shall be made at the Inland Revenue Department accompanied by the prescribed fee of **EC\$65.00**. Please note a Government issued ID is required (one that bears a photo).

TEMPORARY DRIVERS' LICENCE

A temporary driver's licence is required for all visitors and non-immigrants in Anguilla who wish to drive. The licence can be obtained from the Inland Revenue Department or any car rental agency. The licence is valid for a period of three months from the date of issue at a cost of **EC\$67.00** or for a period of 72 hours for a cost of **EC\$40.00**.

- **Applicants must be eighteen years or older, and hold a valid driver's licence issued outside of Anguilla.**

TAXI DRIVER'S PERMIT

A Taxi permit is required in order to operate a taxi. An application for the permit is made to the Transport Board at the Royal Anguilla Police Headquarters. If your application is approved a Taxi Permit number is issued at the Traffic Department. A fee of **EC\$200.00** is payable at the Inland Revenue Department.

- **The receipt and a recent passport size picture should be taken to the Traffic Department.**

DRIVER'S LICENCE FEES

Licences are in five classes.

Class A (Motorcycle)

1yr- \$ 110.00

3yrs - \$ 275.00

Class B (Private)

1yr- \$ 125.00

3yrs - \$ 310.00

Class C (Chauffeur)

1yr- \$ 150.00

3yrs - \$ 375.00

Class D (Truck)

1yr- \$ 190.00

3yrs - \$ 500.00

Class E (Heavy Equipment)

1yr- \$ 250.00

3yrs - \$ 625.00
