- AN ACT Relating to physical therapists; amending RCW 18.74.010,
- 2 18.74.012, and 18.74.023; adding new sections to chapter 18.74 RCW;
- 3 repealing section 17, chapter 297, Laws of 1990; repealing section 18,
- 4 chapter 297, Laws of 1990 (uncodified); providing effective dates; and
- 5 declaring an emergency.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 7 **Sec. 1.** RCW 18.74.010 and 1988 c 185 s 1 are each amended to read
- 8 as follows:
- 9 Unless the context otherwise requires, the definitions in this
- 10 section apply throughout this chapter.
- 11 (1) "Board" means the board of physical therapy created by RCW
- 12 18.74.020.
- 13 (2) "Department" means the department of ((<del>licensing</del>)) <u>health</u>.
- 14 (3) (("Director" means the director of licensing.

- (4)) "Physical therapy" means the treatment of any bodily or
- 2 mental condition of any person by the use of the physical, chemical,
- 3 and other properties of heat, cold, air, light, water, electricity,
- 4 sound, massage, and therapeutic exercise, which includes posture and
- 5 rehabilitation procedures; the performance of tests and measurements of
- 6 neuromuscular function as an aid to the diagnosis or treatment of any
- 7 human condition; performance of treatments on the basis of test
- 8 findings after consultation with and periodic review by an authorized
- 9 health care practitioner except as provided in RCW 18.74.012 ((until
- 10 June 30, 1991)); supervision of selective forms of treatment by trained
- 11 supportive personnel; and provision of consultative services for
- 12 health, education, and community agencies. The use of Roentgen rays
- 13 and radium for diagnostic and therapeutic purposes, the use of
- 14 electricity for surgical purposes, including cauterization, and the use
- 15 of spinal manipulation or manipulative mobilization of the spine and
- 16 its immediate articulations, are not included under the term "physical
- 17 therapy" as used in this chapter.
- 18 (((5))) (4) "Physical therapist" means a person who practices
- 19 physical therapy as defined in this chapter but does not include
- 20 massage operators as defined in RCW 18.108.010.
- 21 (5) "Secretary" means the secretary of health.
- 22 (6) Words importing the masculine gender may be applied to females.
- 23 (7) "Authorized health care practitioner" means and includes
- 24 licensed physicians, osteopathic physicians, chiropractors,
- 25 naturopaths, podiatrists, and dentists: PROVIDED, HOWEVER, That
- 26 nothing herein shall be construed as altering the scope of practice of
- 27 such practitioners as defined in their respective licensure laws.
- 28 **Sec. 2.** RCW 18.74.012 and 1990 c 297 s 19 are each amended to read
- 29 as follows:

- 1 Notwithstanding the provisions of RCW 18.74.010(4), a consultation
- 2 and periodic review by an authorized health care practitioner is not
- 3 required for treatment of neuromuscular or musculoskeletal conditions:
- 4 PROVIDED, That a physical therapist may only provide treatment
- 5 utilizing orthoses that support, align, prevent, or correct any
- 6 structural problems intrinsic to the foot or ankle by referral or
- 7 consultation from an authorized health care practitioner.
- 8 ((This section shall expire June 30, 1991.))
- 9 Sec. 3. RCW 18.74.023 and 1986 c 259 s 124 are each amended to
- 10 read as follows:
- 11 The board has the following powers and duties:
- 12 (1) To administer examinations to applicants for a license under
- 13 this chapter.
- 14 (2) To pass upon the qualifications of applicants for a license and
- 15 to certify to the ((director)) secretary duly qualified applicants.
- 16 (3) To make such rules not inconsistent with the laws of this state
- 17 as may be deemed necessary or proper to carry out the purposes of this
- 18 chapter.
- 19 (4) To establish and administer requirements for continuing
- 20 ((professional education as may be necessary or proper to ensure the
- 21 public health and safety and)) competency, which ((may)) shall be a
- 22 prerequisite to ((granting and)) renewing a license under this chapter.
- 23 (5) To keep an official record of all its proceedings, which record
- 24 shall be evidence of all proceedings of the board which are set forth

- 26 (6) To adopt rules not inconsistent with the laws of this state,

- 8 to read as follows:
- 9 Pursuant to the boards's power in RCW 18.74.023(3), the board is
- 10 directed to adopt rules relating to standards for appropriateness of
- 11 physical therapy care. Violation of the standards adopted by rule
- 12 under this section is unprofessional conduct under this chapter and
- 13 chapter 18.130 RCW.
- 14 <u>NEW SECTION.</u> **Sec. 6.** The following acts or parts of acts are each
- 15 repealed:
- 16 (1) 1990 c 297 s 17; and
- 17 (2) 1990 c 297 s 18 (uncodified).
- 18 NEW SECTION. Sec. 7. (1) Sections 1, 2, and 6 of this act are
- 19 necessary for the immediate preservation of the public peace, health,
- 20 or safety, or support of the state government and its existing public
- 21 institutions, and shall take effect June 30, 1991.
- 22 (2) Section 3 of this act shall take effect January 1, 1992.
