# **JBC Staff Analysis**

Department of Local Affairs and instead requires the General Assembly to appropriate \$25.0 million from the Affordable Housing and Home Ownership Cash Fund that originates from the General Fund to the Department for the expansion of the Middle Income Access Program administered by the Colorado Housing and Finance Authority.

Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$25.0 million cash funds from the Affordable Housing and Home Ownership Cash Fund originating from the General Fund to the Department of Local Affairs for FY 2022-23.

If the Committee adopts L.002, then J.001 should also be adopted.

### **Points to Consider**

### Technical Issues

The bill directs the General Assembly to transfer \$25.0 million to the Department of Local Affairs without specifying a source of funds or a cash fund within the Department to receive the transfer.
