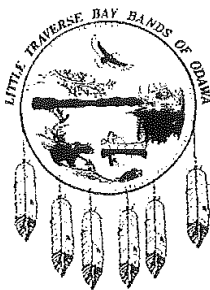

This Court conducted a Show Cause Hearing on March 27, 2008. The Respondent, Charles E. Mulholland, failed to satisfy the Court Order dated November 20, 2007 and a Bench Warrant was issued for failure to comply with the Court Order. Mr. Charles E. Mulholland could not pay the cash bond amount of \$200.00. Respondent admitted failure to satisfy the *Default Judgment* for failure to file catch reports from a Court Order dated September 2001. Respondent testified that he could not pay the \$100.00 due to the Court as he is experiencing financial hardship at this time.

This Court finds Mr. Charles E. Mulholland in Contempt of Court for failure to pay the *Default Judgment*. The Court will not impose a contempt fine but does require Respondent to pay the original \$100.00 fines and court costs due (\$50.00 fine and \$50.00 court cost).

Respondent agreed to pay \$20.00 a month to the Court beginning April 10, 2008. Respondent will pay \$20.00 a month until the total amount due is paid in full.

WHEREFORE, IT IS SO ORDERED that Mr. Charles E. Mulholland pays the above-cited fines and court costs of **\$100.00** (One Hundred dollars) on or by August 10, 2008.



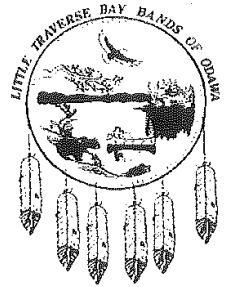

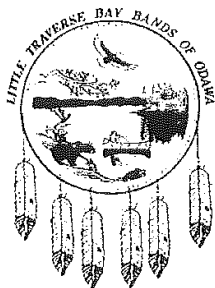

**THE COURT FINDS:**

1. Mr. Mulholland did not appear for the Show Cause Hearing on November 14, 2007.
2. Mr. Mulholland has not paid the outstanding fines and court costs in this matter by September 20, 2007, as ordered by this Court.

**WHEREFORE, IT IS ORDERED THAT:**

1. Mr. Mulholland must pay the \$100.00 in fines and court costs due the Court by December 20, 2007.
2. If Mr. Mulholland fails to pay the fines and costs by this date, he may be found in contempt of court that could result in assessment of additional fines and costs and a warrant being issued for his arrest.

ORDER

A hearing to reinstate the petitioner's commercial captain's fishing license was held in this matter on September 1, 2006, before the Honorable Jenny Lee Kronk, Little Traverse Bay Bands (LTBB) of Odawa Indians Associate Tribal Judge. Present at the hearing were the respondent, Charles E. Mulholland, and Kevin Willis, LTBB Chief Conservation Officer.

Findings of Fact

1. LTBB issued a captain's fishing license to Charles E. Mulholland on January 12, 2001.
2. Mr. Mulholland failed to file 5 monthly catch reports as required by the license.
3. On July 20, 2001, Conservation Officer Willis issued a citation to Mr. Mulholland for violation of Section XXII, subsection (A) "Harvest Reporting and Sampling" that requires each holder of a captain's fishing license to report his harvest for each calendar month.
4. On July 26, 2001, Tribal Court sent Mr. Mulholland a plea by mail to the address indicated on his fishing license application.
5. The plea by mail form was not returned to the Court and Mr. Mulholland did not respond within 14 days.
6. On September 20, 2001, the Honorable Michael Petoskey, LTBB Chief Judge, entered a default judgment of \$100.00 (\$50.00 fine and \$50.00 court costs) against Mr. Mulholland.
7. Mr. Mulholland did not pay the fine and costs within 14 days as directed.
8. On October 10, 2001, the Court suspended Mr. Mulholland's fishing privileges and published notification of the suspension in the tribal newsletter.

Conclusions of Law

The Court finds that Mr. Mulholland failed to file his catch reports as required by his captain's license and that the Court properly assessed fines and costs when Mr. Mulholland failed to respond to the citation. Therefore, Mr. Mulholland must pay the fines, costs and reinstatement fee to have his captain's license returned.



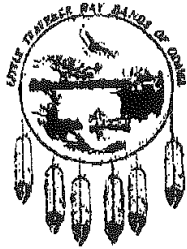

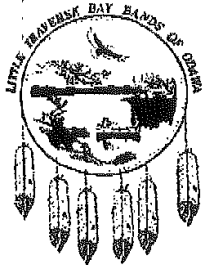
