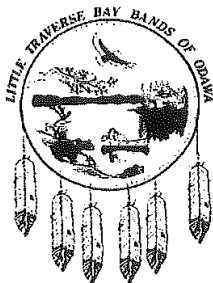

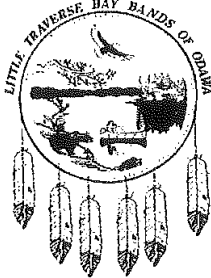

DEFAULT JUDGMENT

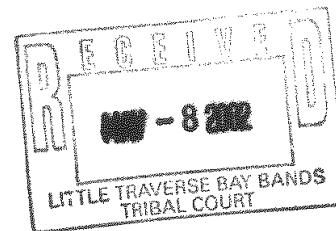
1. Default judgment is entered in the amount of \$ 50.00 (\$25.00 Fine and \$ 25.00 Court Costs) stated on the Plea by Mail Form.
2. Return this ORDER with a certified check or money order in the amount of the judgment by May 23, 2002 by 5:00pm.

If you fail to pay, the Court will REVOKE your LTBB Natural Resources privileges and you will be required to petition the Court for reinstatement of your LTBB Natural Resources privileges. Once privileges are revoked, they will not be reinstated until the fine and costs are paid in full AND you will be required to petition the Court for reinstatement of treaty privileges. You will also have to pay a filing fee of \$ 50.00 when you file the petition.
